Dear David:

Thank you for the opportunity to make application for capital cost share funding for 2013. As you are aware, the Town of Stony Plain has always made every effort to ensure that the capital requests forwarded to you are of the utmost priority. The Town of Stony Plain has and will continue to search for more efficient and economic ways of completing the required capital projects including provincial and federal grants. Our 2013 Capital Plan is detailed below:

2013 Capital Projects:

- Boiler room renovation: The renovation of the boiler room in the Glenn Hall Centennial Arena which will allow the existing boiler room to meet Alberta Building Code and the replacement of the existing boiler with a high efficiency condensing hot water heater. (Carry Forward)
- Digital Direct Control System: The installation of a digital direct control system will allow the mechanical and ice plant settings to be controlled and turned down or off at particular times when the building is not in use. (Carry Forward)
- Concession Improvements: A number of improvements are being made to the concession including the replacement of the flooring, counter tops, cabinets, and appliances.
- Exhaust Fans: Replacement of the exhaust fans in the hallways, dressing rooms and concessions.
- Arena Condenser Platform: The existing platform to access the condenser is considered a safety issue as the access to the areas they are required to perform weekly maintenance on is on the opposite side of the platform so the staff are required to us a ladder which in this situation does not meet OH&S regulations.

I am learning the relationships and the required reporting schedules to all partners and was remiss in the sending of the proposed 2014 capital items for the Glenn Hall Arena. The following has been included in our 2014 budget process for consideration. Our initial budget meetings are scheduled for early September. Confirmation of the full capital plan can be communicated by the end of September. Project list includes:

Arena Roof replacement \$600,000

Arena Cladding (siding) \$700,000 Arena Parking Lot Paving \$726,000

The 2015 Capital budget does not include any arena capital unless one of the above is moved to 2015 as we deliberate in the coming weeks.
