
# INTRODUCTION: WHAT ARE WE ASKING COUNCIL FOR?

  - Policy Area Maps
  - Policy Definitions
  - Policies
- Section 9:
  - Requires a Regional Context
    Statement
  - Requires a MDP Update



# INTRODUCTION: WHAT IS A REGIONAL CONTEXT STATEMENT?

- Address what we are doing to implement the RAMP within our MDP
- Align our definitions and policies so that the Region is all on the same page
- NOTE: Does not mean the EMRB gets to decide how we get there. The County still gets to decide what our policies and regulations look like

# INTRODUCTION: RELATIONSHIP TO MDP AND LUB PROJECTS

- Municipal Development Plan Project: 2023-2025
  - Conveniently happening at the same time RAMP updates are required
  - Confirmed with EMRB that including the RAMP updates within the MDP Project is satisfactory
  - Goal of EMRB approval in Q4 2024

- Land Use Bylaw ReDesign: 2023-2025
  - Also happening at the same time
  - Working in partnership with MDP
    Project so that policy and regulation align
  - Not an EMRB requirement to update, but good practice to do




# RCS POLICY EXAMPLE

RAMP Policy 4.1.7:	Two or more municipalities that share a prime agricultural area(s) must coordinate the designation of the area to recognize the geographic continuity.
Existing Policy:	None in the MDP, included in Intermunicipal Development Plans.
Action Required?	Yes
MDP Project Response:	The MDP Project will coordinate the alignment of Prime Agricultural Area(s) with neighbouring municipalities.



## DEFINITIONS THAT WE NEED TO ALIGN WITH





# RCS DEFINITIONS EXAMPLE

Specialty Agricultural Land:	Provides optimum conditions for agricultural production due to unique factors including but not limited to soils, water supply, and climatic conditions. Specialty agriculture land may be located in prime agricultural areas and in all other agricultural areas.
Existing MDP Definition:	No definition in the glossary, but the existing MDP makes reference to specialty agriculture within Section 4.2: Prime Agriculture Areas.
Action Required?	Yes
MDP Project Response:	Include definition that aligns with the definition in the RAMP.
