Administration presented Bylaw 2017-22 to the reconvened public hearing.

Verbal Submissions:

1. Mike Evans, area resident, opposed to Bylaw 2017-22 and referred to the presentation by the applicant explaining the historical information related to lands with permits.

2. Theresa Plante, area resident, opposed to Bylaw 2017-22 being concerned with maintaining restrictions on the land, contamination of the lake, and the number of lots proposed in the development.

3. Jonathan Thompson, representing the residents who signed the petition opposing Bylaw 2017-22 with concern of the quality of the lake, increased use of the lake and responsible lake users, and that the proposed development does not support the environmentally sensitive areas.

5. Ken Horn, applicant, Greg McKenzie and Ray Makowecki, consultants for the applicant, presented support for Bylaw 2017-22 for lake preservation and that County standards will be complied with related to shoreline setbacks, drainage, and lot ratio, as well as with environment laws.

Additional Written Submissions:

1. Elaine Boughen, area landowner, opposed to Bylaw 2017-22 that will allow for a road development to create a south access road connecting the development to Township Road 521 that will infringe on privacy, affect wildlife, and the impact on Jackfish Lake.

2. Family owned cottage resident of Jackfish Lake opposed to Bylaw 2017-22 that will increase population affecting the environment and state of the lake.
