RFD 12-160 Tri Leisure Centre (TLC) Pool Air Handling Unit.

Proposed Motions

That Council approve funding up to \$357,000.00 from Restricted Surplus - Recreation Facilities as Parkland County's contribution towards the new Tri Leisure Centre Pool Air Handling Unit.

That Council approve Administration recovering \$357,000.00 through the Tri Leisure Centre Tax Levy to be deposited back into the Restricted Surplus - Recreation Facilities account.

A motion was made by Council Member Darrell Hollands that funding up to \$357,000.00 from Restricted Surplus - Recreation Facilities as Parkland County's contribution towards the new Tri-Leisure Centre Pool Air Handling Unit, as presented. The motion carried unanimously.

A motion was made by Council Member Phyllis Kobasiuk that administration be directed to recover \$357,000.00 through the Tri-Leisure Centre Tax Levy to be deposited back into the Restricted Surplus - Recreation Facilities account, as presented. The motion carried unanimously.

B. Development Services Matters

RFD 12-162 Rural Community Network Improvements

Proposed Motion

That Council authorize facility improvements to the rural communications system and rural community network to be funded with up to \$220,000 from the Community Infrastructure Improvement Fund (CIIF) and \$400,000 from Municipal Sustainability Initiative (MSI).
