BYLAW 2026-12

BEING A BYLAW FOR THE PURPOSE OF RESCINDING BYLAW 01-2007, BYLAW 06-2010, AND BYLAW 19-2010, COLLECTION OF ARTERIAL/COLLECTOR ROADWAY OFF-SITE LEVIES

---

**WHEREAS** the *Municipal Government Act*, RSA 2000 c M-26, authorizes council to rescind bylaws of the municipality;

**WHEREAS** Parkland County adopted Bylaw 01-2007 Collection of Arterial/Collector Roadway Off-Site Levies on February 27, 2007;

**WHEREAS** Parkland County adopted Bylaw 06-2010 Amendment to Collection of Arterial/Collector Roadway Off-Site Levies on May 25, 2010;

**WHEREAS** Parkland County adopted Bylaw 19-2010 Amendment to Collection of Arterial/Collector Roadway Off-Site Levies on July 6, 2010;

**NOW THEREFORE** the Council of Parkland County, duly assembled and under the authority of the *Municipal Government Act*, RSA 2000 c M-26, as amended, hereby enacts the following:

**TITLE**

1. This Bylaw shall be known as the "Rescinding the Collection of Arterial/Collector Roadway Off-Site Levy Bylaws (Bylaw 01-2007, Bylaw 06-2010, and Bylaw 19-2010)".

**DEFINITIONS**

2. The following definitions will apply to the corresponding words in this Bylaw:

(1) "County" means the municipality of Parkland County in the Province of Alberta.

**INTERPRETATION**

3. The headings in this Bylaw are for reference purposes only.

**ENACTMENT**

4. Should any provision of this Bylaw be deemed invalid then such invalid provision will be severed from this Bylaw and such severance will not affect the validity of the remaining portions of this Bylaw, except to the extent necessary to give effect to such severance.

5. Bylaw 01-2007, Bylaw 06-2010, and Bylaw 19-2010 are hereby rescinded.

6. This Bylaw shall come into force and take effect on the day of third reading and signing thereof.
