BUILDING SETBACK - ASSUMPTIONS

1. PROPOSED BUILDING SETBACKS ARE BASED ON BUSINESS INDUSTRIAL OR MEDIUM INDUSTRIAL DISTRICTS.
2. RANGE ROAD 262A, TOWNSHIP ROAD 530A, AND BEVINGTON ROAD ARE CONSIDERED MUNICIPAL ROAD R.O.W. WITH A BUILDING SETBACK DISTANCE OF 23.0m FROM PROPERTY LINE.
3. CANADIAN NATIONAL RAILWAY R.O.W. BUILDING SETBACKS TO BE DETERMINED. THE CURRENT SETBACK SHOWN IS 23.0m FROM PROPERTY LINE.
4. ALL ROAD R.O.W. WITHIN THE SUBDIVIDED AREA ARE CONSIDERED INTERNAL SUBDIVISION ROADS WITH A BUILDING SETBACK DISTANCE OF 12.0m FROM PROPERTY LINE.
5. A 9.0m SETBACK DISTANCE WAS USED FOR THE SIDE AND BACK PARCEL PROPERTY LINES.
