- Note: we have not highlighted small changes today because they remain consistent with what GPC heard in January

Engagement Process

- Four in-person engagement sessions held
- One virtual engagement session held
- County SMEs were present at all engagement sessions
- Surveys administered on all proposed bylaws
- General consistency between proposed bylaw changes and sentiment from engagement sessions and surveys

Review by Bylaw

Animal Control Bylaw

- **Bylaw Purpose**

- Regulate and control wild, household pets, animals and birds and activities relating to them
- Ensure the safety, health and welfare of people and the protection of people and property

- **Identified Through Engagement**

- Having a plan in place for animals that are strays or have been hit on the highway is important
- Overall, but not universally, the availability of chicken husbandry seem to be viewed as a positive
- Dogs barking at night is identified as an issue
- Concerns were raised about noise generated by roosters in subdivisions

Community Standards Bylaw

- **Bylaw Purpose**

- Ensure the safety, health and welfare of people and protection of people and property
- Address nuisances, including unsightly property
- Provide regulations affecting neighborhood livability

- **Identified Through Engagement**

- There are concerns around noise and light from neighbouring properties, specifically at night
- Comments around privacy fences leaned towards allowing fence height to change
- Unsightly properties are an issue

Fire Services Bylaw

- **Bylaw Purpose**


- Promote safe and viable communities
- Significant expansion of existing bylaws

- **Identified Through Engagement**

- Fireworks comments leaned in favour of more control over firework sale and discharge
- Burning garbage may not be an issue right now, but it may become an air quality issue in the future


Fire Services Bylaw – Focused Engagement

- Fireworks Use on Labour Day
 - Wildfire safety concerns around fireworks use on Labour Day
 - Review Committee recommends not permitting firework use on Labour Day due to increased wildfire risk
 - Note: this recommendation is consistent with insights expressed during engagement



Fire Services Bylaw – Focused Engagement

- Fireworks Use on Lots Less than 4 Hectares in Size
 - Review Committee recommends not permitting firework use on lots less than 4 ha.
 - Note: this recommendation is consistent with insights expressed during engagement



Parks Bylaw

- **Bylaw Purpose**

- Ensure the safety, health and welfare of people and the protection of people and property

- **Identified Through Engagement**

- Off-leash dogs in parks are an issue
- There is some confusion around what is and is not allowed in County parks
- Enforcement of the bylaw is important to people's enjoyment of parks
- The topic of consumption of liquor in parks came up, generally in the negative
- People's enjoyment of various types of activities in parks can come into conflict if the types of activities conflict

Traffic Control and Regulation Bylaw

- **Bylaw Purpose**

- Regulate pedestrian and vehicle traffic with the County


- **Identified Through Engagement**

- Note: Traffic Control received the fewest comments of any of the bylaws.
 - Traffic has gotten louder and there should still be a way to enforce unnecessary noise levels
 - There should be more enforcement related to speeding

Traffic Control - Focused Engagement

- School Zone Hours

- During the bylaw research phase, the topic of consistent school zone hours for the three schools adjacent to County-owned roads was raised
- An issue related to confusion around school zone times
- The Major Bylaw Review Committee recommends that relevant school zones in Parkland County being moved to an all-day model
 - 7:30 – 4:30 Monday to Friday
- Note: this is consistent with the results of the public engagement process



Off-Highway Vehicle Bylaw

- **Bylaw Purpose**


- Regulate and control the operation of Off-Highway Vehicles (OHV) on public land subject to the direction, control and management of the municipality

- **Identified Through Engagement**

- Comments are split – both in favour and against OHV oversight
- Concerns about environmental damage caused by OHVs
- Noise of OHVs, even on private property, interferes with others' enjoyment of their own land
- Enforcement of the bylaw is desired

Off-Highway Vehicles - Focused Engagement

- Minimum Age of Operator
 - Bylaw enforcement officers can properly identify OHV users with government-issued identification (i.e. driver's license)
 - The Major Bylaw Review Committee recommends requiring OHV users to be at least 14 years of age and be in possession of a Class 7 Driver's License (learner's permit) when using an OHV on public land in the County
 - Note: this is not in alignment with the plurality of results of the survey question on this topic



Unauthorized Use of County Land Bylaw (New)

- **Bylaw Purpose**

- Ensure safety, health and welfare of people and the protection of people and property
- Respect people, activities and things in, on or near County land
- Identify County land use rights, exclusive or otherwise, which may be granted by the municipality
- Provide regulations affecting the public use of County land

- **Identified Through Engagement**

- There is confusion around the different designations of land, and there may need to be more public education on this
- Regulate camping, fires, vehicle use on County Land

Cats

- **Purpose**

- To test public sentiment on the topic of cats in Parkland County
- Note: this is not a bylaw

- **Identified Through Engagement**

- There is no consistent opinion about whether and how the County should approach regulation of cats
- Topics ran the continuum from licensing, to management of stray/feral cats, to sheltering abandoned or seized cats

Next Steps

- Review and revisions of draft bylaws based on What we Heard outcomes and GPC insights
- Legal review
- Bylaw consideration by Council
 - Seven draft bylaws will be provided for Council consideration through the fall
 - Should they be approved, bylaw changes would likely become effective January 2024
 - Some effective dates will be concurrent because changes in one bylaw sometimes have effects on other bylaws

 - Inform public of bylaw reading schedule
 - Inform public of opportunities to address Council
 - Advertise any changes approved by Council
