Lake Wabamun is a popular summer destination for boaters in the Capital region. It is situated 60 km west of Edmonton off of Highway 16 covering approximately 82 square kilometers and is one of the most heavily used lakes in the province. It had three major launch points, Wabamun, Lake Wabamun Provincial Park and Seba Beach, and several private or undeveloped access points in rural subdivisions where hand or small launching small boat is possible. Parkland County, in an effort to limit parking challenges in rural subdivisions is limiting the use of many of these access points and last year Seba Beach closed their launch facility to the public. An increase in demand by boaters for improved boat launch facilities lead to an examination of current and future boat launch facilities on the lake. A preliminary assessment was completed in 2013 by EDA Collaborative. The demand for launch opportunities and possible alternative launch locations were examined. The resulting strategy identified opportunities for upgrading existing launch facilities on the lake. As the deepest boat launch location on the Lake with the most amenities and opportunities to expand, the Village of Wabamun launch site is seen as a primary development

opportunity to service both lake side resident users and day users from the Edmonton area as well as a wide surrounding area of central Alberta. This site offers both expansion opportunities for land based infrastructure and the opportunity for increased water access. As part of this application we intend to expand the launch ramps and lanes from two to three and add ten additional floating dock facilities, since few if any opportunities exist on the lake for public moorage. Adjacent day use facilities will be upgraded by adding benches and picnic facilities along with the addition of a boat inspection and invasive species information area. The existing 370' long former federal pier will be repaired and ice flow protection put in place. The partners on the project, being the Village of Wabamun and Parkland County, have met regularly and determined the need to enhance launch opportunities, especially in light of the closure of the Seba Beach launch site on the west end of the lake last year. This leaves only the Village launch site and the provincial park launch site for larger boats to access the lake. The Provincial launch is in moonlight Bay and is separated from the main lake by a CN train trestle which limits the size of boats that can enter the lake under the trestle, leaving the Village site as the only option for large boats and sail boats to access the main lake. The result of this project will be easier access to the lake with expanded support facilities and the long term sustainability of the Village launch site. It will result in a decrease of the use of private or undeveloped launch sites which have a negative impact on the shoreline ecosystem and will address the spread of invasive species in our lake with the addition of the boat inspection and invasive species information area. The partners will participate by sharing the financial costs along with their expertise. Twice yearly meetings will be used to evaluate the projects success and form plans to address future issues.

With the ever increasing challenge of blue green algae in many other area lakes, including Lac Ste. Anne and Lake Isle, the use of Lake Wabamun, which is essentially algae fee, continues to rise. This, along with population increases and an increase of recreational boaters in the capital region has resulted in increasing pressure on local facilities. The cost of upgrading would be a substantial burden on a small municipality without support from our neighbors and the provincial government. The survey, done as part of the 2013 Boat Launch Study, commissioned by Parkland County, indicated that the majority of launch users are from communities east of Lake Wabamun: Edmonton, Spruce Grove, Stony Plain, Parkland County, Sherwood Park, etc.. Cottage development along the shoreline and the creation of summer villages resulted in a huge increase in developed lots around the lake, surpassing 1300 in 1996 which has added to the pressure. Those with sailboats commented on the inability to navigate under the bridge as a reason they did not use the launch in the Provincial Park and Wabamun is the only launch on the lake where a larger boat can launch. This upgrading project has been identified as a priority by the village, Parkland County

as well as many of the summer villages around Lake Wabamun. This project will provide enhanced regional recreational services, reduce traffic into the waterfront area by increasing launch opportunities, reduce pressure on private or undeveloped launch areas and our neighboring summer villages who also experience a large degree of rogue parking and launching in areas ill-equipped for such activity. The project would also be a positive response to reducing the risk of invasive species of plants and animals entering Lake Wabamun.

The expansion and upgrade will allow the facility to be able to support the growth in recreational activities among Albertans and the increasing populations being seen in the Capital region and throughout central Alberta. The expansion would take a great deal of pressure off the existing facility, which sees thousands of visitors on weekends creating lineups that extend north to Highway 16, creating traffic challenges throughout the Village. The large number of users can cause multi hour waits for boat launching or loading. The large majority of boaters do not come from Wabamun. Based on survey results from the 2013 study, the average length of all craft launched in Wabamun is approximately 18 feet. Forty percent of boaters drove from Edmonton to launch. The next most common origin for the boaters included Stony Plain, The Village of Wabamun, St. Albert, Spruce Grove, Betula Beach. Other users surveyed came from Leduc, Parkland County, Onoway, Seba Beach, Sherwood Park, Drayton Valley, Point Allison, and Fort Saskatchewan. Over three-quarters (78%) of survey respondents had launched a boat onto Lake Wabamun and almost half (49%) used the launch in the Village of Wabamun.

Parkland County and our neighboring summer villages of Betula Beach, Seba Beach, Kapasiwin, Lakeview, Point Allison would benefit from expanded facilities and moorage by the reducing the need and use of private or undeveloped launch areas in their communities and around the lake itself.

### **Project Priority**

An increase in demand by boaters for improved boat launch facilities warranted an examination of current and future boat launch facilities on the lake. A preliminary assessment of the existing launch facilities was completed by EDA in 2013. It examined water and land based conditions and the demand for launch opportunities and possible alternative launch locations elsewhere on the lake. The resulting strategy identified opportunities and constraints for upgrading both existing and alternative launch facilities on the lake. The study was sponsored by Parkland County in cooperation with the Village of Wabamun, Summer Village of Betula Beach, Summer Village of Kapasiwin, Summer Village of Lakeview, Summer Village of Point Alison, Summer Village of Seba Beach, Paul First Nation, Trans Alta and Wabamun Provincial Park.

The community consultation for the study included a resident survey, a group use or organization survey, as well as an intercept survey of launch users at the Village of Wabamun and the Provincial Park. Residents of the various summer villages and the Village of Wabamun were surveyed. A questionnaire was developed by the consulting team and distributed to residents of the summer villages (Betula Beach, Seba Beach, Kapasiwin, Lakeview, Point Allison), the Village of Wabamun, and
