Government of Alberta Status Update on Professional Signoff for Regulatory Documents under the Alberta Wetland Policy

The update indicates that as of May 1, 2017, Alberta Environment and Parks (AEP) will require signoff on regulatory documents submitted under the *Alberta Wetland Policy* by an authenticating professional.
