**Re:** **NOTICE OF MOTION regarding West Inter-Lake District Regional Water Services Commission (WILD) Operating and Maintenance Service**

Take notice that at the October 13, 2015 Council meeting, Mayor Rod Shaigec will MOVE:

"THAT Parkland County provide the operational maintenance service to the West Inter-Lake District Regional Water Services Commission (WILD) commencing on the WILD Water Commission's start-up date."

### Information Supporting the Notice of Motion

The WILD Water Services Commission has asked Parkland County to provide operational services for their new water system. WILD is a new water transmission system running through Parkland County to service our municipal neighbours including Wabamun and the Paul First Nation. Future plans include expanding the system to service Onoway and the Alexis Nakota Sioux First Nation.

The WILD water system is nearing the end of construction and is expected to be up and running in early 2016. If this initiative were approved by Council, Parkland County would enter into a five-year agreement with WILD and would hire a new temporary contract position to look after the water system.

Staff would train and become familiar through the commissioning of the system in early 2016. Service will need to be provided to the commission in accordance with Alberta Environment Regulations and this will be one of the key items to monitor.

With the addition of a new contract position, providing operations and maintenance services for WILD can easily be incorporated into existing Parkland County operations. At this point the WILD Commission is only looking for someone to maintain and operate the system. The Commission will handle administration and utility billing for the system.
