BYLAW 2022-11

BEING A BYLAW TO ESTABLISH FEES AND CHARGES FOR THE PROVISION OF GOODS AND SERVICES
WITHIN PARKLAND COUNTY, IN THE PROVINCE OF ALBERTA

WHEREAS pursuant to the Municipal Government Act, R.S.A. 2000, c.M-26, and amendments thereto, a municipality has the authority to establish fees and charges for the provision of goods and services; and

WHEREAS the Council of Parkland County wishes to establish certain fees and charges;

NOW THEREFORE the Council of Parkland County, duly assembled and under the authority of the Municipal Government Act, as amended, hereby enacts the following:

TITLE

1. This bylaw shall be known as the "2023 Fees and Charges Bylaw".

APPLICATION

2. This bylaw establishes rates, fees and charges for certain goods and services provided by Parkland County.
3. All fees are non-refundable unless otherwise noted.

- 7. Bylaw 2021-20 and Bylaw 2021-26 are hereby repealed effective January 1, 2023.
- 8. This bylaw shall come into force and take effect on January 1, 2023.
