Programs were busting at the seams, service levels and spontaneous use were extremely high, facility user groups were back in full force, and we had a wide array of new and returning special events. In addition, we continued to implement our long-term capital and infrastructure plan thanks to the support of the three owner municipalities (City of Spruce Grove, Town of Stony Plain and Parkland County) as well as through unique partnerships and grant funding. A few of the facility improvements in 2023 included:

- Replacement of the arena condenser and cooling tower
- Renovation of the former Shotz Lounge, turning it into a multi-purpose space both for programs as well as rentals opportunities.
- Addition of a new electronic scoreboard/digital screen in the aquatic center thanks to a partnership with the Parkland Pirates Aquatic Club.
- Upgraded lockers in the men's and women's change rooms.

On behalf of our entire team, thank you to all of you who accessed the facility in 2023 whether it was a one-time visit or daily visits, we appreciate you all! We work very hard to ensure each visit is an enjoyable one, so thank you for your continued feedback to help us make that happen.

1 RE-SIGNED AFFORDABILITY GRANT

January 2023, TLC Preschool re-signed the Affordability Grant Agreement with the Government of Alberta. The agreement offers wage top ups for Preschool employees who meet the requirements and subsidizes program fees for families who qualify.

2 CANADA SUMMER JOBS FUNDING

We received \$12,600 from Canada Summer Jobs grant funding which supported 3 students as TLC Summer Camp Instructors.

3 2023-2024 PLAY PARKLAND

From 9 schools we had 1200 students participate in the 2023-2024 PLAY Parkland program. We received \$2500 from Canadian Tire Jumpstart- Community Development Grant, which was used to decrease the registration fee for students in financial need.

4 CHILD MINDING SERVICES

Child Minding services resumed in January 2023 after closing due to the pandemic in 2020.

1 LEISURE POOL RE-OPENED

We re-opened the Leisure Pool after its unexpected closure in October 2022. The remainder of the holiday school break and the month was BUSY in the aquatics centre! People missed having access to the Leisure Pool for three months and were eager to visit us in January.

3 NEW PROGRAM COORDINATOR

Donna McKean, Aquatics Program Coordinator for 16 years, retired. Chris Kay, long standing staff member and full-time Shift Leader filled her shoes, which she did the previous year for three months while covering a medical leave.

2 NEW SWIM PROGRAM MODEL

The Winter program session was when we launched the new swim program model. We made our own additions to the Lifesaving Society learn-to-swim program, so it was comparable to the Red Cross model we previously offered.

4 ANNUAL POOL SHUTDOWN

Annual Pool Shutdown occurred between September 4th-24th. Regular pool shutdown tasks occurred – scrubbing basins, painting, deep clean changerooms, changing out baffles and socks – but the bigger items were:

- o Reinforcement of the slide platform
- o Slide flume repair
- o Reinforcement of the pillar bases
- o Steamroom repair
- o Air Handling Unit work
- o New locker install











Capital Revenue



Staff Profile

CHRIS KAY



How long have you worked at?

It will be 16 years in September at the TLC.

What inspired you to pursue a career in Aquatics?

I started working at the TLC in high school, so I didn't want to have a job where I wouldn't enjoy what I was doing, where I wasn't learning anything and where I couldn't grow. This was the perfect spot, and I have always loved swimming. I was a kid that you could never get out of the pool. I spent most of my summers at the Stony Pool. It was also a good career choice for getting myself through university. Very flexible.

In the 16 years, how has your role evolved?

I started as a lifeguard/instructor when I was in high school and after I completed university. I decided I wanted to take on more leadership roles, so I applied for a part-time leadership position and then applied for a full-time position when the opportunity came up. I applied for that, and I got it.

So that was great. I was a full-time shift leader for five years. (Maybe a little longer) During my role as a full-time shift leader, I also had the opportunity to work as a scheduler, which was a nice challenge. That was definitely different from being on the pool deck and dealing with the public.

I was also always very passionate about instructing, so I constantly talked to Donna McKeen, discussed lessons, and got into teaching leadership courses like WSI because that's where my passion really was.

When Donna went on medical leave, I took her spot for a few months while she was away, and I really liked it. I applied for the role when she was retiring. And here I am.

Do you ever get to go out and instruct anymore?

I can do leadership courses. It's been a little busy right now since I had this position. I haven't had the opportunity to teach. But while I was working as a shift lead, I was still teaching a lot. But in the last year, I haven't had the time.

Are you going to try to balance that somehow?

Eventually, I plan to return to teaching more leadership courses once everything is settled.

How long have you been in the current role of your aquatic program coordinator?


It will be one year, on June 30th.

What are the key responsibilities and duties you oversee in your role?

In my role, I am in charge of programming lessons and deciding what lessons we will be running and if there are programs we should tweak. Also, all the instructors report directly to me, so I make sure that they're getting the guidance that they need, that they feel ready to teach, and try to figure out any sort of things that I can do to help them be their best at instructing.

What is the most rewarding part of your job here at the TLC?

When I go out on the pool deck and watch lessons, I see all the participants' smiling faces and how much they're enjoying their lessons. Also, listening to the instructors and saying how they love this class or how this kid really improved is the most rewarding part. That's really why I took this job: I wanted to see that growth in the instructors and in the community.
