BYLAW 2021-16

BEING A BYLAW TO ESTABLISH SPECIFIC FEES AND CHARGES WITHIN THE HAMLET OF WABAMUN  
IN PARKLAND COUNTY.

**WHEREAS** pursuant to the Municipal Government Act, RSA 2000, c.M-26 a municipality has the authority to establish fees and charges for the provision of goods and services;

**WHEREAS** in accordance with Order in Council 386/2020 effective January 1, 2021 the Village of Wabamun was dissolved and the former area of the village designated as a hamlet in Parkland County;

**WHEREAS** under the provisions of Order in Council 386/2020 bylaws and resolutions of the former area of the village continue to apply until the bylaws or resolutions are repealed, amended or replaced by the Council of Parkland County;

**WHEREAS** there are specific fees and charges that must be established for the Hamlet of Wabamun;

**NOW THEREFORE** the Council of Parkland County, duly assembled and under the authority of the Municipal Government Act, as amended, hereby enacts the following:

1. The fees and charges included in Schedule "A" to this Bylaw are hereby established and effective within the Hamlet of Wabamun until midnight December 31, 2021.
2. The following former Village of Wabamun Bylaws are hereby repealed
  - Bylaw No. 12-2019: Master Rates and Fees Bylaw
  - Bylaw No. 06-2020: Amendment to Master Rates and Fees Bylaw
  - Bylaw No. 10-2020: Amendment to Master Rates and Fees Bylaw
  - Bylaw No. 11-2020: Amendment to Master Rates and Fees Bylaw
3. Should any provision of this bylaw be deemed invalid then such invalid provision will be severed from this bylaw and such severance will not affect the validity of the remaining portions of this bylaw, except to the extent necessary to give effect to such severance.
4. This bylaw shall come into force and take effect on the day of third reading and signing thereof.

1. Cemetery

a) Columbarium Niche	\$500.00
b) Memorial Plaque Space	\$200.00
c) Niche Plaque	\$550.00
d) Memorial Plaque	\$300.00
e) Columbarium Niche – Open on weekdays (except holidays)	\$20.00
f) Columbarium Niche – Close on weekdays (except holidays)	\$20.00
g) Columbarium Niche – Open on weekend (including holidays)	\$60.00
h) Columbarium Niche – Close on weekend (including holidays)	\$60.00
i) Niche Plaque Instillation – Weekday (except holidays)	\$60.00

2. Jubilee Hall

a) Hardwood side	\$150.00 + GST per day
b) Carpet side	\$150.00 + GST per day
c) Full Hall – includes hardwood side, carpet side, and kitchen	\$400.00 + GST per day
d) Multi-day Event – Full Hall and Kitchen	\$650.00 + GST from 4pm the day before the event to noon the day after the event for a single day event, additional days charged at regular rates.
e) Damage Deposit	\$500.00
f) Kitchen	\$100.00 + GST per day
g) Administration Fee	\$100.00
h) Cleaning Fee	\$30.00 per hour
i) Lost Key Charge	\$500.00 + GST

3. Coal Diamond Sports Park and Campground

a) Full Sports Park Rental	\$700.00 + GST

REGULATION: This campground is a group site and will be rented to one group at a time with one person designated as responsible for the applicable fee(s) and site activity. The two ball fields and soccer field and washrooms will be included with the campground as one rental package for the full sports park. Rental rates are for weekend use: either Friday 4pm – Sunday 8pm OR on a long weekend with an official statutory holiday attached Friday 4pm – Monday 8pm.

b) Full Sports Park Rental Damage Deposit	\$500.00
c) Campground Only Rental	\$250.00

REGULATION: This campground is a group site and will be rented to one group at a time with one person designated as responsible for the applicable fee(s) and site activity. Washrooms will be included with the campground as one rental package. Rental rates are for weekend use: either Friday 4pm – Sunday 8pm OR on a long weekend with an official statutory holiday attached Friday 4pm – Monday 8pm.

d) Campground Rental Damage Deposit	\$500.00

4. Bus User Fees

a) Driver

\$25.00 + GST per hour from the time the bus leaves the public work shop until it returns

b) Mileage

\$0.60 + GST per kilometer as recorded and submitted by the bus driver
