AGRICULTURAL SERVICES - CORE SERVICES

Weed Inspection Program

- Positions have been filled. Three of six inspectors are returning from last year.
- One (1) Weed Notice case is going to pre-trial discovery

Agronomy Program

Surveys to be conducted in	
Clubroot	Inspect every parcel seeded to canola.Conduct detailed survey for new pathotypes.
Fusarium	 Target sampling 12 fields to monitor this disease. Results have come back from 9 of 12 samples tested positive for Fusarium graminearum.
Bertha Armyworm	 Four trap sites, we had two trap sites in 2016. We have expanded the number of sites and traps assist a U of A student with a research project.
Diamondback Moth	Two trap sites, same as in 2016.

Horticulture Program

- Diseased trees at the Acheson Fire Hall will be removed and replaced.
- Plans to construct temporary bed at County Centre for Canada flag floral planting. Flower pot arrangements will take into account Canada's 150th birthday and primary colours will be red and white
- Working with two University of Alberta students that have developed hemp erosion control matting that contains grass seed. We will setup sites on existing revegetation projects to compare the hemp matting with traditional matting such as straw and coconut fibre.
- Continue to support Green Acreages Guide program.

Hazardous Tree Program

Investigations pending as a result of a request from the Atim Creek
 Homeowners Association to remove trees on MRs to develop pathways.

Pest Management

 Forestry for a farm once considered to be an escapee problem; now
 all wild boar sold off the facility.
- Strong support for Flowering Rush Management Program with about 50 concerned stakeholders at a provincial management program meeting.
- Continued support for Invasive Species management with more than 200 attending our annual conference in Lacombe.



FIRE SERVICES - Q1 INCIDENT DATA


Year First Quarter Comparison of Total Incident Activity – Incident that have occurred in Parkland County






INCIDENTS BY LOCATION

INCIDENT BY AREA, BY TYPE








TIME OF DAY STATISTICS








LAND LINE VS CELL PHONE STATISTICS

Event	Status
New Radio Console	In procurement process
Meridian Tower Move	Channel's 2 83 and Calmar CPO were moved January 23/17. The completion of this project will run in line with the new console upgrade.
Backup Facility	Will be installing 911 lines into the building asap and starting the process of setting up the rest of the Alberta 911 Standards requirements.
CAD Mapping	Parkland GIS and ECC have worked together to prepare project. Have been given data from Alberta Health Services and AltaLIS which provides packet data for all of our dispatch municipalities. Import scheduled for mid-February.
Call Centre Upgrades	Will be making upgrades to current center to allow for compliance to Alberta 911 Standards and improve current work environment for employees.
Radio Vendor Service Contract	Will begin process to sign acquire a contract with a vendor with specific response and maintenance plan to ensure radio infrastructure is maintained properly.
