

#### **ADMINISTRATIVE REPORT**

#### INTRODUCTION

Parks, Recreation and Culture is presenting recommendations for the Recreation and Culture Capital Cost Share requests received from its partners. These requests address lifecycle and standard maintenance activities that ensure the effective an efficient operation of the facilities that our residents can access.

#### **BACKGROUND**

As part of the Recreation and Culture Cost Share Agreements we have with our municipal partners, Council may, at their discretion, provide funding support for capital repairs or upgrades at the facilities outlined in each of the agreements. Administration has received requests from the City of Spruce Grove, the Town of Stony Plain, The Town of Devon and the Stony Plain and Parkland Pioneer Museum. The details of the requests are outlined below.
