BYLAW 2024-16

BEING A BYLAW FOR THE PURPOSE OF RESTRICTING THE USE OF FERTILIZERS BY WATERBODIES IN
PARKLAND COUNTY

WHEREAS the *Municipal Government Act*, RSA 2000 c M-26, authorizes council to pass bylaws for municipal purposes regulating the safety, health, and welfare of people and the protection of people and property; people, activities, and things in, on, or near a public place that is open to the public; and the enforcement of bylaws; and

WHEREAS Council of Parkland County is wanting to protect the health of waterbodies in Parkland County from the detrimental effects of fertilizers; and

WHEREAS Council of Parkland County has deemed it necessary to have restrictions on the use of fertilizers in Parkland County;

NOW THEREFORE the Council of Parkland County, duly assembled and under the authority of the *Municipal Government Act*, RSA 2000 c M-26, as amended, hereby enacts the following:

TITLE

1. This Bylaw shall be known as the "Restricted Use of Fertilizers by Waterbodies Bylaw".

DEFINITIONS

2. The following definitions will apply to the corresponding words in this Bylaw:
 - (1) "Bylaw Enforcement Officer" means any person appointed by Council or the Chief Administrative Officer (CAO) of Parkland County to enforce this Bylaw;
 - (2) "CAO" means the Chief Administrative Officer of Parkland County;
 - (3) "Council" means the elected council of Parkland County;
 - (4) "County" means the municipality of Parkland County in the Province of Alberta;
 - (5) "Fertilizer" means any substance or mixture of substances, containing nitrogen, phosphorus, potassium or other chemicals that is manufactured, sold or represented for use as a plant nutrient or aid to plant growth provided that, for greater certainty, "Fertilizer" does not include natural vegetation compost;
 - (6) "Natural Compost" means material resulting from the decomposition of organic matter such as food scraps, yard waste and other biodegradable materials;
 - (7) "Owner" means with respect to a property located within the municipal boundaries of Parkland County;
 - (8) "Parkland County's Fees and Charges Bylaw" means the Enforcement Services Fees and Charges Schedule approved by Council as part of the budget approval process; and
 - (9) "Waterbody" means any location where standing or flowing surface water is present, permanent and naturally occurring including but not limited to lakes, wetlands, streams and rivers.

PROHIBITION

3. No person shall apply, spray, distribute or otherwise use, or cause to be applied, sprayed, distributed or otherwise used, any Fertilizers, except for Natural Compost, in any subdivision listed in Schedule A of this Bylaw; which are subdivisions or hamlets adjacent to waterbodies in Parkland County.

EXCEPTIONS

4. This Bylaw does not apply to the application of Fertilizer:
 - (1) on lands used for the purpose of agriculture, including lands used for turf grass or sod production;
 - (2) on lands used as a golf course or a golf driving range where that land use is in accordance with the zoning in Parkland County's Land Use Bylaw 2017-18;

- (3) on lands used for horticultural production, such as greenhouses or market gardens; or
- (4) on lands used as nursery stock for tree production or reforestation.

ORDERS AND REVIEW

- 5. If a designated officer finds that a person is contravening this or any other enactment that the municipality is authorized to enforce or a bylaw, the designated officer may, by written order, require the person responsible for the contravention to remedy it if the circumstances so require pursuant to sections 545 and 546 of the Municipal Government Act.
- 6. Every person who fails to comply with an Order issued pursuant to this Bylaw within the time set out in the Order commits an offence.

ENFORCEMENT

General Penalty Provision

- 7. A person who contravenes this Bylaw by:
 - (1) doing any act or thing which the person is prohibited from doing; or
 - (2) failing to do any act or thing the person is required to do
 is guilty of an offence.
- 8. Any person who is convicted of an offence pursuant to the Bylaw is liable on summary conviction to a fine not exceeding ten thousand dollars and in default of payment of any fine imposed to a period of imprisonment not exceeding six months.

Violation Tickets and Penalties

- 9. Where a Peace Officer or County employee believes that a person has contravened any provision of this Bylaw, the Peace Officer may commence proceedings against the person by issuing a Violation Ticket pursuant to the *Provincial Offences Procedures Act*, RSA 2000, c P-34.
- 10. Where there is a specified penalty listed for an offence in Parkland County's Fees and Charges Bylaw, that amount is the specified penalty for the offence.
- 11. Where there is a minimum penalty listed for an offence in Parkland County's Fees and Charges Bylaw, that amount is the minimum penalty for the offence.
- 12. This section does not prevent any Peace Officer from issuing a Violation Ticket requiring a Court appearance of the defendant, pursuant to the provisions of the *Provincial Offences Procedures Act*, RSA 2000, c P-34, or from laying an Information in lieu of a Violation Ticket.
- 13. The levying and payment of any fine or the imprisonment of any period provided in this Bylaw shall not relieve a person from the necessity of paying any fees, charges, or costs from which that person is liable under the provisions of this Bylaw or any other Bylaw.
- 14. The County can exercise discretion in the application of this Bylaw and its contents as defined in Section 529 of the *Municipal Government Act*, RSA 2000 c M-26.
- 15. If the complainant fails to supply evidence to a Parkland County representative on any issue within this Bylaw, the County may elect not to investigate the complaint.
- 16. A Peace Officer may use discretion, mediation and provide increased awareness and education in lieu of applying Violation Tickets and penalties.
- 17. All Violation Tickets issued by the County and heard by the Court are to be supported by witness statements and may require Court attendance by the complainant to validate facts. The final decision to proceed with a specified penalty will be at the discretion of the Court, when the matter is heard, and will be based on supporting evidence.

False Information

- 18. No person shall provide false or misleading information to any Peace Officer, or County Employee.

Interference with a Peace Officer

- 19. No person shall interfere with or obstruct a Peace Officer or County employee in the exercise of their powers and duties pursuant to this Bylaw.

Investigation

- 20. A complaint may be investigated by a County employee and enforced by a Peace Officer.

21. For the purpose of conducting an inspection to determine whether a person is complying with this Bylaw, a County employee or Peace Officer may:

- (1) enter onto lands at a reasonable time;
- (2) require the production for inspection documents or thing relevant to the inspection;
- (3) require information from a person concerning a matter related to the inspection; and
- (4) take photographs and/or soil samples.

22. No person required to produce documents, things or information by a County employee or Peace Officer shall fail to respond forthwith.

ENACTMENT/TRANSITION

23. Should any provision of this Bylaw be deemed invalid then such invalid provision will be severed from this Bylaw and such severance will not affect the validity of the remaining portions of this Bylaw, except to the extent necessary to give effect to such severance.

24. This Bylaw shall come into force and take effect on the day of third reading and signing thereof.

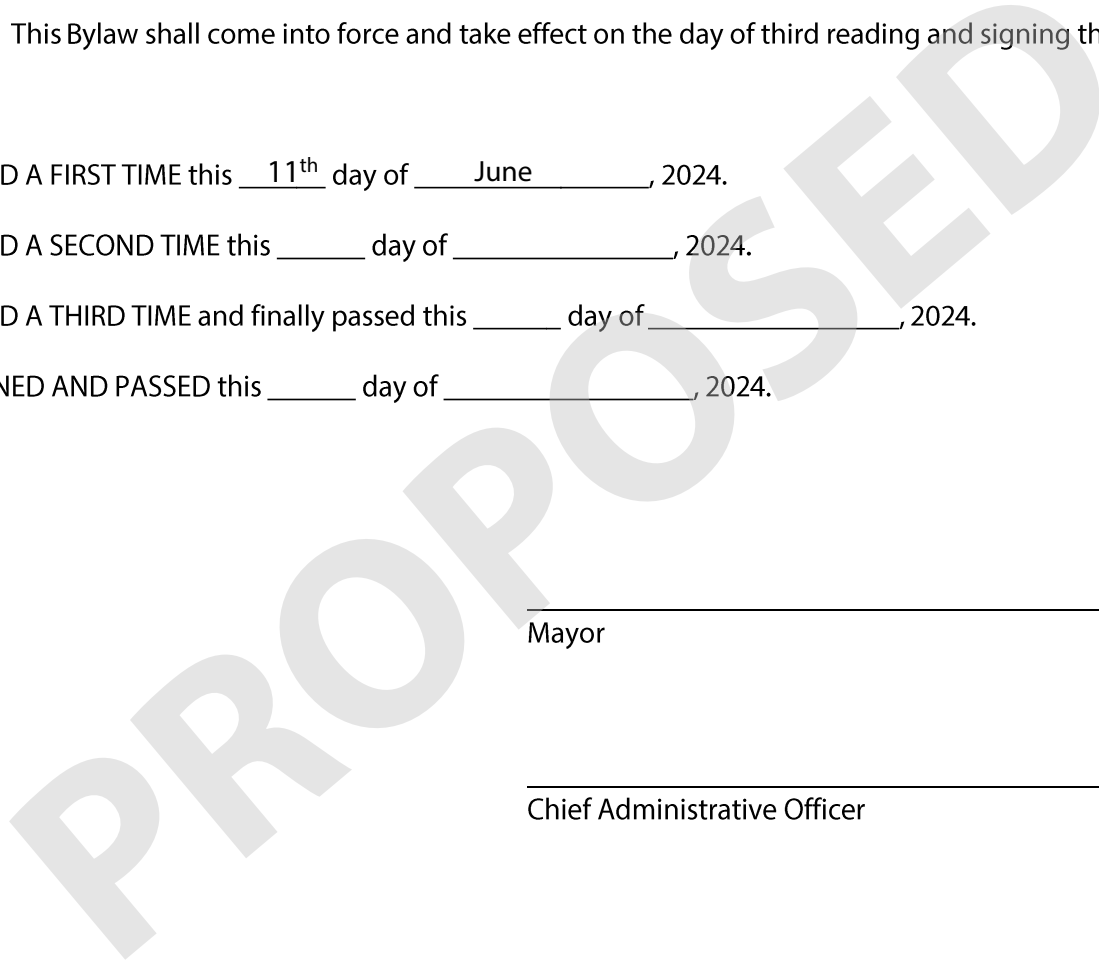
