- 1. Aleem Kanji, Canadian National Fireworks Association, requested that a lot size restriction be removed from Bylaw 2023-17; and, opposed to the wind speed of 15 km included in Bylaw 2023-17.
- 2. Brian Charles Smith, Hamlet of Wabamun resident, opposed to the fireworks and fire pit sections of Bylaw 2023-17, stating they are too restrictive.

- 3. Tina Bichel, Star Lake Estates resident, referred to her written submission to request that Section 50 of Bylaw 2023-17 be amended, as follows: "A permit will be issued to any resident who applies for a fireworks permit at least 30 days before the activity date. Neighboring residents shall be notified and have 10 days to appeal the permit to Fire Services. Fire Services will be authorized, at his/her sole discretion, to give a ruling on the appeal."
- 4. Michael Mostaway, Acheson business owner, opposed to the 4 hectares of land size regarding fireworks in Bylaw 2023-17, and suggested that 4 acres be replaced with at least 1 acre of land size; and, opposed to restrictions on specific days to use fireworks as people celebrate all kinds of holidays and special events of Bylaw 2023-17. Mr. Mastaway supports the idea of notifying neighbors neighbors within 72 hours of setting off a fireworks display.
- 5. Floyd Young, Star Lake Estates resident, opposed to the fireworks section of Bylaw 2023-17.
