Bylaw 2017-19 - Amending Land Use Bylaw 20-2009 (Outdoor Participant Recreation Services and Outdoor Shooting Ranges)

**Proposed Motions**

**Section 1, subsection (3) of Bylaw 2017-19, "OUTDOOR SHOOTING RANGE means a development consisting of a facility that is outdoors and designed for the safe discharge of firearms including, but not limited to rifles, shotguns, pistols, silhouettes, skeet, trap, or any similar firearms for the purposes of sport shooting, target practice, training, or shooting competitions." be deleted and to now read, "OUTDOOR SHOOTING RANGE means a development consisting of a facility that is outdoors and designed for the safe discharge of firearms for the purposes of sport shooting, target practice, training, or shooting competitions."**
