BYLAW 2021-06

**BEING A BYLAW FOR THE PURPOSE OF REPEALING CERTAIN FORMER VILLAGE OF WABAMUN  
BYLAWS OR RESOLUTIONS**

**WHEREAS** the Municipal Government Act, RSA 2000, c.M-26 authorizes council to pass bylaws for municipal purposes;

**WHEREAS** in accordance with Order in Council 386/2020 effective January 1, 2021 the Village of Wabamun was dissolved and the former area of the village designated as a hamlet in Parkland County;

**WHEREAS** under the provisions of Order in Council 386/2020 bylaws and resolutions of the former area of the village continue to apply until the bylaws or resolutions are repealed, amended or replaced by the Council of Parkland County;

**WHEREAS** there are a number of former village bylaws or resolutions that can be repealed as the subject matters is addressed by a Parkland County bylaw or the former village bylaws or resolutions are irrelevant;

**NOW THEREFORE** the Council of Parkland County, duly assembled and under the authority of the Municipal Government Act, as amended, hereby enacts the following:
