## **GRAVEL TRUCK PATROL OFFENSIVE SUMMER 2013**

#### **LOCATIONS:**

- GRAVEL PITS LOCATED WITHIN PARKLAND COUNTY
- HIGHWAY 16 YELLOWHEAD
- HIGHWAY 60 ACHESON
- SECONDARY HIGHWAY 627

# **OBJECTIVE:**

Over the past two summers there has been an increase in amount of traffic violation complaints received. We are to target violations which include: speed, load securement, occupant restraint, distracted driving.

Patrols have been requested throughout the summer to focus on traffic violations and Commercial Vehicle Safety Alliance (CVSA) inspections. Days will be set aside for each focused patrols. RCMP members will work along side with Officers of Parkland County to enforce any legislations and regulations and to assit in CVSA inspections.

# **FOCUSED PATROL DUTIES:**

- Traffic Enforcement patrols:
  - Assigned officers are to focus patrol on traffic violations.
  - Locations may vary each patrol date. The main area of focus shall be the larger haul areas. For example.
    - RD 43
    - Hwy 627, 770, 759, 16
    - RD 273 South of Hwy 627
    - Hwy 627 east of Hwy 60
    - Any other areas within Parkland County which has a current haul agreement.

#### CVSA days.

- Parkland county have officers trained to coduct these type of inspections.
- These officers are conducting CVSA Level 1 inspections.

- Their focus is on gravel truck traffic
- Officers can inspect other commercial vehicles if traffic is slow.
- Locations again will be the high traffic locations
- Hwy 627 at RD 32A (Keephills)
- RD 51 north of Hwy 16
- RD 43 south of Hwy 627.
- Other safe locations in the county
- Officers are to ensure locations chosen are safe.

Officers are not to issue the suspensions. Any violation tickets on a haul road will forwarded to the Gravel Point Peace Officer B. BACKSTROM. (PARKLAND COUNTY ENFORCEMENT)

- 11. Rear reflectors

- 12. Left Signal
- 13. Right Signal
- 14. Hazard Lights
- 15. Brake lights
- 16. License plates and lights
- 17. Check brakes
- 18. Mudquards
- 19. Mirrors
- 20. Flags/Flares
- 21. Fire Extinguisher
- 22. Door Identification GVW, Tare, Company logo
- 23. Low air warning

Members are encouraged to complete one of these commercial vehicle inspection forms every stop.

These forms are to be keep and forwarded to Officer BACKSTROM of Parkland County Enforcement Services.

At the end of this enforcement period, a review of this plan will be completed and a report with statistics and enforcement numbers, best practices, issues etc will be prepared and forwarded to all partners.
