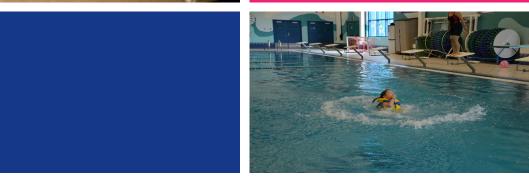

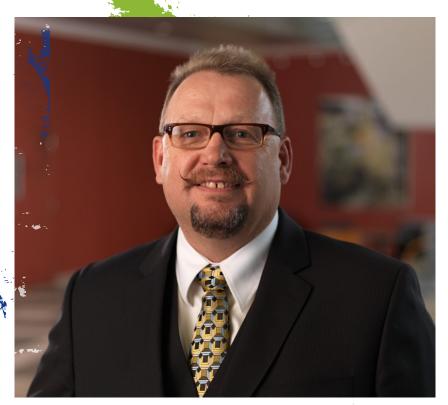

TLC for Everyone Program

The TLC continued the commitment to providing individuals and families with financial challenges the opportunity to use TLC facilities at a subsidized rate in 2012.

TLC for Everyone is a collaborative community initiative that utilizes resources from across the region to administer a subsidy program aimed at easing the financial barriers to being physically active. Participants are provided a 10-admission pass at 75% of the regular rates. The TLC provides a 25 % discount, the Tri Community Health and Wellness Foundation provides 50 % of the discounted rate.

Our Community

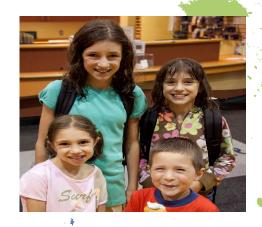
Celebration was the underlying theme of all that we did in 2012. In addition to the activities and events held in celebration of the TLC's 10th anniversary, we found time to recognize the unique contribution of each of our municipal partners and owners by providing residents of Spruce Grove, Stony Plain and Parkland County with a designated day of complimentary access to the TLC.

The TransAlta Tri Leisure Centre further demonstrated our commitment to maintaining regional leadership in healthy and active lifestyles by being actively involved in community events. In 2012, the TLC took our message of healthy active living into the communities through event appearances and by making contributions to local groups that share our commitment to fostering community health and wellbeing. Some of our favourite events included City Slickers, the Great White North Triathlon and the Little Monsters Bash.



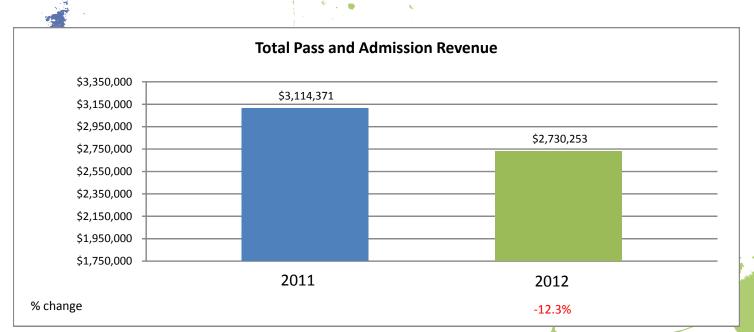
Annual Passes and Daily Admissions

The TLC saw a decrease in the total number of annual passes and admissions sold in 2012. The decrease in both annual passes and admissions is not easily attributed to a single cause. Despite the decrease in pass and admission revenues, the TLC continued to be well utilized by Tri-Municipal Region residents during peak hours. Both the SMS Equipment Fitness Centre and the Realty Executives and Aqua-Tek Scuba Aquatic Complex were very popular amongst TLC visitors.













Facility Rentals and Overall Usage

2012 was a tremendously busy year for the TLC. The total number of hours booked increased by 13% in 2012. The following information provides an overview of the various ways Tri-Municipal Region residents use the TLC:

1. Facility Rentals: Facility rentals represented 21% of facility usage at the TLC, down 10% from 2012.

Total facility rental revenues were \$902,217 and represent 13% of the total revenues generated in 2012. Revenues generated through facility rentals decreased by 8% in 2012. The decrease in both rental hours and rental revenues can be attributed to facilities being allocated to the hosting of the 2012 Alberta Winter Games and to the loss of a significant spring/summer arena user.

- 2. Programs and Services:
 Time allocated to TLC programs and services represented 58% of total hours booked in 2012, an increase of 60% from 2011. \$977,892 (15% of total revenues) were generated through TLC program and service offerings in 2012.
- **3.** Internal/Maintenance: Time allocated to Internal/Maintenance represented 21% of total hours booked in 2012 which was a slight decrease from 2011.

Special Events

The TLC is the host facility for a number of major events each year. Events hosted at the TLC include sporting events, ranging in size from local hockey tournaments to international high school volleyball tournaments, as well as commercial opportunities such as the regional trade show representing businesses from across the Tri-Municipal Region.

In February of 2012, the TLC served as a key host venue for the 2012 Alberta Winter Games, which brought young athletes together from all over the province in the spirit of competition and camaraderie. The TLC was not only a host venue for a number of sporting events, but served as the central gathering place for all the athletes. The 2012 Alberta Winter Games were widely hailed as the best games ever. TLC board, administration and staff are extremely proud of the role we had in this success.

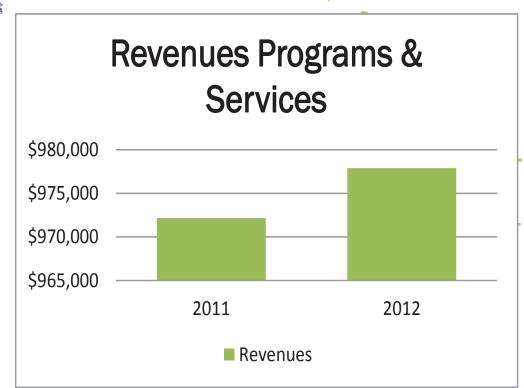
Programs and Services

The TLC continues to focus on the development and delivery of quality programs and services for residents of the Tri-Municipal Region and beyond. 2012 saw an already competitive marketplace become even more competitive with an increasing variety of sport, recreation and fitness programs and services being offered by local businesses.

In 2012, registration in TLC programs and services increased by 3%, with a total of 12,966 participants. Another 20,109 participants took advantage of the wide variety of drop-in programming offered facilitywide.

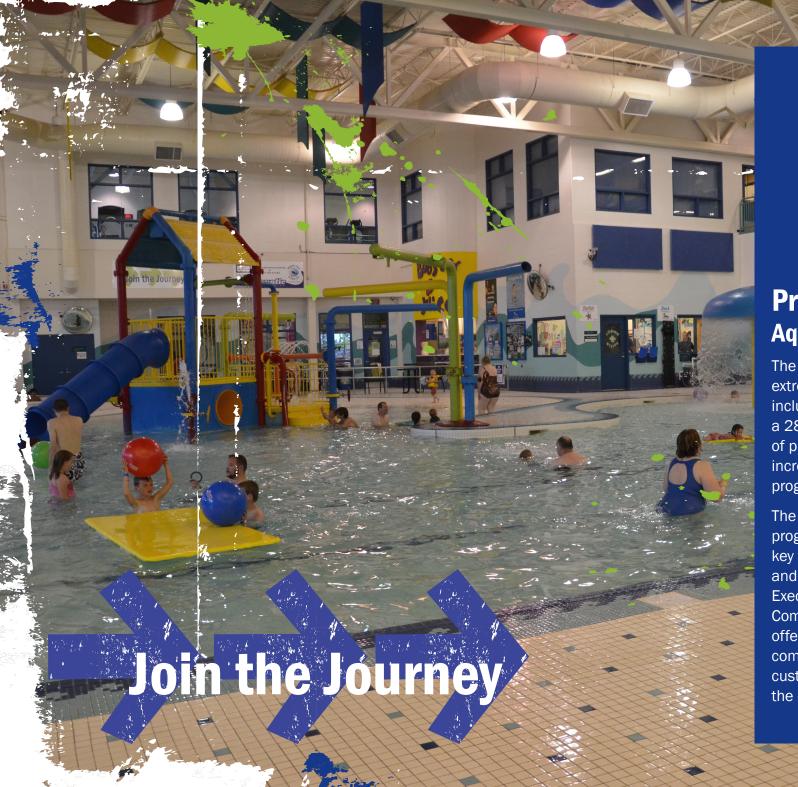
Wellness

The wellness department faced many challenges in 2012 including growing competition throughout the Tri-Municipal Region and a decrease in the total overall visitations to the TLC. Despite these challenges, revenues generated through the TLC professional wellness services, including Personal Trainers and Dietitians, increased 13%.









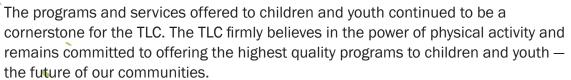
Programs and ServicesAquatics

The Aquatics department had an extremely successful 2012. Highlights include a 15% increase in revenues, a 28% increase in the total number of program spots available and a 6% increase in total number of aquatic program registrations.

The tremendous success of the aquatic programs and services is a result of two key factors. Changes to the scheduling and allocation of time in the Realty Executives and AquaTek Scuba Aquatic Complex allowed more programs to be offered. The aquatic leadership team's commitment to the delivery of exceptional customer experiences was a key factor in the department's 2012 successes.



Programs and Services Children and Youth



The Alberta Recreation and Parks Association (ARPA) recognized the TLC's commitment to physical literacy-based children and youth programs with the High Five ® Outstanding Achievement Award. The HIGH FIVE® Outstanding Achievement Award is given to an individual, organization or municipality who has created new opportunities, provided support or increased the exposure of HIGH FIVE®.

High Five is Canada's only comprehensive quality standard for children's sport and recreation programs. It represents a true commitment to quality physical activity and is based on research involving child development experts, recreation and sport professionals, families and industry leaders.

The TLC was an early adopter and advocate of the High Five program and worked closely with ARPA to train both administrative and frontline staff in the principles of High Five. The TLC is currently working through the process of becoming the region's first High Five accredited organization.

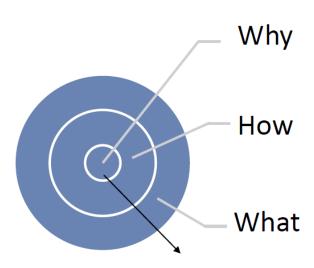
Research shows the experiences children have in recreation and sport at an early age carry a life-long impact. Positive experiences help children become capable, caring adults who contribute more effectively to the community in the future. TransAlta Tri Leisure Centre staff are passionate about delivering quality recreational experiences.

Marketing and Communications

In 2012, the TLC continued to streamline our marketing and communications strategies in order to more effectively use our resources, while continuing to connect with and educate our community about the wide variety of healthy, active living opportunities available at the TLC.

The celebration of the 10th anniversary offered an opportunity to reflect on the successes and the learnings of the last decade. This major milestone also presented a unique opportunity to reintroduce residents of the Tri-Municipal Region to the TLC. In 2012, we employed an innovative marketing model to refresh our brand and the way we delivered our programs and services. Our strategy was simple: authentically share what we stand for as an organization (health, vitality, etc.). With this fresh customer-centric approach we were able to motivate and inspire communities into action.

The following diagram shows the innovative approach TLC is adopting for 2012.



Why: our belief system that drives the identity and existence of the organization. It embraces a philosophy that staff can exude and customers embrace. Why: **Live Life to the Fullest**

It's not a catch phrase, tagline, or slogan. "Live life to the fullest" is the driving force behind everything we do at the TransAlta Tri Leisure Centre.

How: speaks to the emotional rationalization of the brain. Research shows this is how most consumers make their purchasing decisions.

We believe when people are operating at their optimal health, anything is possible. They are living life to the fullest.

What: Is the final phase and becomes the "cherry on top". Where most organizations try to lead with this sales approach, the TLC will already have customers drawn into the sales funnel through our belief system. It's the same approach Apple Inc. uses.

Sponsorship Project

Corporate sponsorship has played a key role in the sustainable success of the TransAlta Tri Leisure Centre. 2012 marked the completion of many of our corporate sponsorship agreements. Administration had been hard at work on a corporate sponsorship project for the better part of the last two years. The outcomes of the corporate sponsorship project were a number of both new and renewed corporate sponsorship agreements being executed in 2012. The following corporations have committed to a shared vision of healthy, active communities: AquaTek Scuba, Beaverbrook Developments Ltd., Realty Executives, SMS Equipment and, of course, TransAlta.

The sponsorship project was considered a huge success as \$405,000 in secondary naming rights sponsorships was secured over the next five years and \$1.9 million was secured over the next ten years for the overall naming rights.

Facilities and Operations

The TLC's operations and maintenance team are a group of seriously dedicated professionals who work tirelessly behind the scenes to ensure that each and every person visiting the TLC has an exceptional experience.

2012 presented the operations and maintenance team with their fair share of challenges. Each of the 2012 challenges were met head on by the team. Because of their commitment and hard work, the following major projects were initiated in 2012:

- Studio: flood and repair, replacement of floor
- Detailed Energy Report
- Capital Infrastructure Lifecycle Study
- AHU1 replacement project
- · Annual aquatic complex shut down
- · Painting and building maintenance
- Landscaping

In addition to the ongoing building maintenance required to ensure the TLC physical structure stands the test of time, the operations and maintenance team also plays an integral role in the set up and take down of all major events hosted at the TLC. The operations and maintenance team truly impact all aspects of the TLC.



2012 Financials

Several key projects, including a comprehensive compensation survey, collective bargaining and a financial review were undertaken by administration in 2012. The completion of the compensation survey was an integral component of the collective bargaining process.

Despite the majority of departments coming in under budget on the expense side, revenues were also lower than budgeted. Overall expenses were 1% under budget while revenues were 8% under budget. As a result, the TLC reported an overall operational deficit of \$118,117 in 2012.

The majority of the revenue is generated by membership and admission sales.

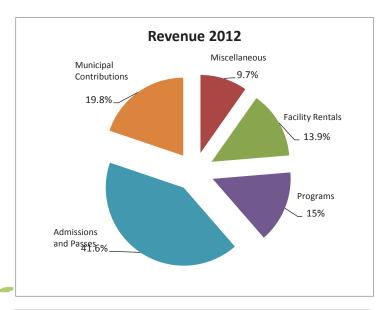
Municipal contributions account for 19.8% of revenue shared proportionately between the three municipal owners.

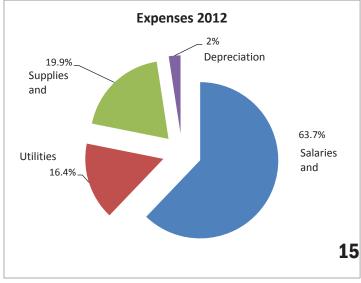
The majority of expenses are allocated to salaries and benefits.

The staffing compliment has remained relatively constant over the past ten years.

Utilities (power, gas, water) continue to represent a significant expense, accounting for 16.4% of total operating costs.

A (\$118,117) unrestricted operating deficit was realized before depreciation expense.





TLC Staff Features

The TLC is very proud of the impact that our programs and services have on residents of the Tri-Municipal Region. The many positive experiences would not be possible without the hard work and dedication of TLC staff members.

Gail McGinnis - Masters Swim Coach

Who knew that one of the world's top Masters swimmers is also an employee of the TLC? Gail McGinnis, who is one of our Masters Swim coaches, is also a dynamite swimmer in her own right. She is currently ranked #1 in Canada in her age group, top 5 in the world in three of her events, and top 10 in three more.

Not only a champion swimmer, Gail also coaches our Masters swim program. This is a program for adult swimmers that was started in 2008 by Jenine Armstrong, TLC Aquatics Supervisor. It provides people in the community the opportunity to swim with the advantage of having a coach for tips and technical corrections. It has been a success ever since its inception and Gail is a big part of that. "Gail was already a Masters swimmer herself and she was a coach with the Spruce Grove Barracudas Summer Swim Team. She was a perfect fit! She was qualified, talented and from the area", says Jenine.

Talking to Gail about the Masters program, it is easy to see why she is a popular coach. "We have everything from triathletes to beginners to other Masters swimmers in the program", she says. Despite the varying needs of the program members, Gail is constantly adjusting her workouts and training to meet their needs. "Swimming is all about technique. The better your stroke is, the less drag in the water, and the faster you go," Gail relates. But to talk to those who know her, the popularity of swimming in the TLC's Masters program might also be about Gail herself. Jenine Armstrong would agree. "One of the main reasons the program is a success is because of Gail's dedication to the swimmers. They really enjoy her. The continued improvement of the swimmers in turn motivates Gail."

As for the benefits of working at the TLC and doing what she loves to do, Gail says "I owe my success to the TLC, for sure. I swim here, run here, train in the gym upstairs... I wouldn't be where I am if I could not do that." And Gail is poised for her most successful year yet. She is competing in Provincials in Calgary and in Ottawa at Nationals. Go Gail!

Sherrie Savage - Supervisor of Operations

Sherrie Savage is the TLC's Supervisor of Operations, which means she is responsible for how the facility looks and feels for our patrons. She oversees both the Arena/Fields and Custodial teams, and has done so for over ten years.

"She started about a month before me", says Milton Topolnisky, another 10-year employee of the TLC. In fact, many of Sherrie's staff are long-term employees (three more received 5-year service awards this fall). "It says a lot when so many of her staff have been here for such a long time," says Vivian Pratt, Manager of Operations and Maintenance, "She is definitely doing something right."

Among the long list of things that Sherrie is doing right is the fact that our building continues to look so great and not show its age. "When visitors from other recreational facilities come here, they cannot believe how great our floors look for being ten years old", says Vivian. Sherrie and her team take great pride in our facility and it shows.

Working at the TLC has benefitted Sherrie too. "My coworkers have coerced me into joining activities that have now become a part of my routine. Working out with them has increased moral and allowed us to get to know each other on a more personal level. Being around the TLC promotes engagement in fitness."

"I have so many things I love about my job." Sherrie says. "I get to go to work every morning and spend the day with people who want to be the best they can be. When they don't feel up to the day, the team brings them up and gets the best out of them. I have never learned so much than I have from my job and my team. Ten years went by in the blink of an eye."

TLC Board of Directors

The TLC is proudly owned by the municipalities of Spruce Grove, Stony Plain and Parkland County. While the three municipalities own the physical structure that makes up the TLC, they have developed a unique approach to ensure the effective oversight of the facility's management and operation.

A memorandum of agreement exists between the three owners and the Tri-Municipal Leisure Facility Corporation. As a not-for-profit corporation incorporated under the Companies Act of the Province of Alberta, the role of the corporation is to govern, manage and operate the facility. The Board of Directors is made up of three representatives from each municipality — two of the representatives are elected officials while the remaining board member is a member of the public at large.
