

PARKLAND COUNTY

BY-LAW NO. 63-2003

BEING A BYLAW OF PARKLAND COUNTY, IN THE PROVINCE OF ALBERTA, TO ESTABLISH WARD BOUNDARIES FOR PARKLAND COUNTY, TO ESTABLISH THE NUMBER OF COUNCILLORS TO BE ELECTED TO SERVE ON PARKLAND COUNTY COUNCIL AND TO PROVIDE FOR THE ELECTION OF THE CHIEF ELECTED OFFICIAL BY THE ELECTORS OF THE COUNTY.

WHEREAS, Section 143(4) of the Municipal Government Act, Chapter M-26, Revised Statutes of Alberta, 2000, and amendments thereto enables Council to pass a Bylaw specifying the number of Councillors to serve on the Council of the County; and

WHEREAS, Section 148(2) of the Municipal Government Act, Chapter M-26, Revised Statutes of Alberta, 2000, and amendments thereto enables Council to pass a Bylaw to change the ward boundaries for the County, and change the number of wards and specify the number assigned to each ward in the County; and

WHEREAS, Section 148(2) of the Municipal Government Act, Chapter M-26, Revised Statutes of Alberta, 2000, and amendments thereto enables a Council to pass a Bylaw specifying that there will be one Councillor elected for each ward established; and

WHEREAS, the Municipal Government Act, Chapter M-26, Revised Statutes of Alberta, 2000, and amendments thereto provides that a Council may pass a bylaw providing for the chief elected official of a municipality to be elected by a vote of the electors of the municipality;

NOW THEREFORE, the Council of Parkland County in the Province of Alberta duly assembled, and pursuant to the authority conferred upon it by the Municipal Government Act enacts as follows:

1. For the purposes of the October 2004 general municipal election and thereafter, Parkland County Council shall be comprised of a mayor and six (6) Councillors with one (1) Councillor elected from each ward.
2. The number and boundaries of each of the six (6) wards shall be as illustrated on the map titled as **Schedule "A"**, which is attached and forms part of Bylaw 63-2003, and shall exclude any and all incorporated municipalities and Indian Reserves situated therein;
3. The Chief Elected Official of Parkland County shall be elected by a vote of electors of the County.
4. This Bylaw takes effect on the final passing thereof.

Bylaw 63-2003 be given first reading this 10<sup>th</sup> day of November 2003.

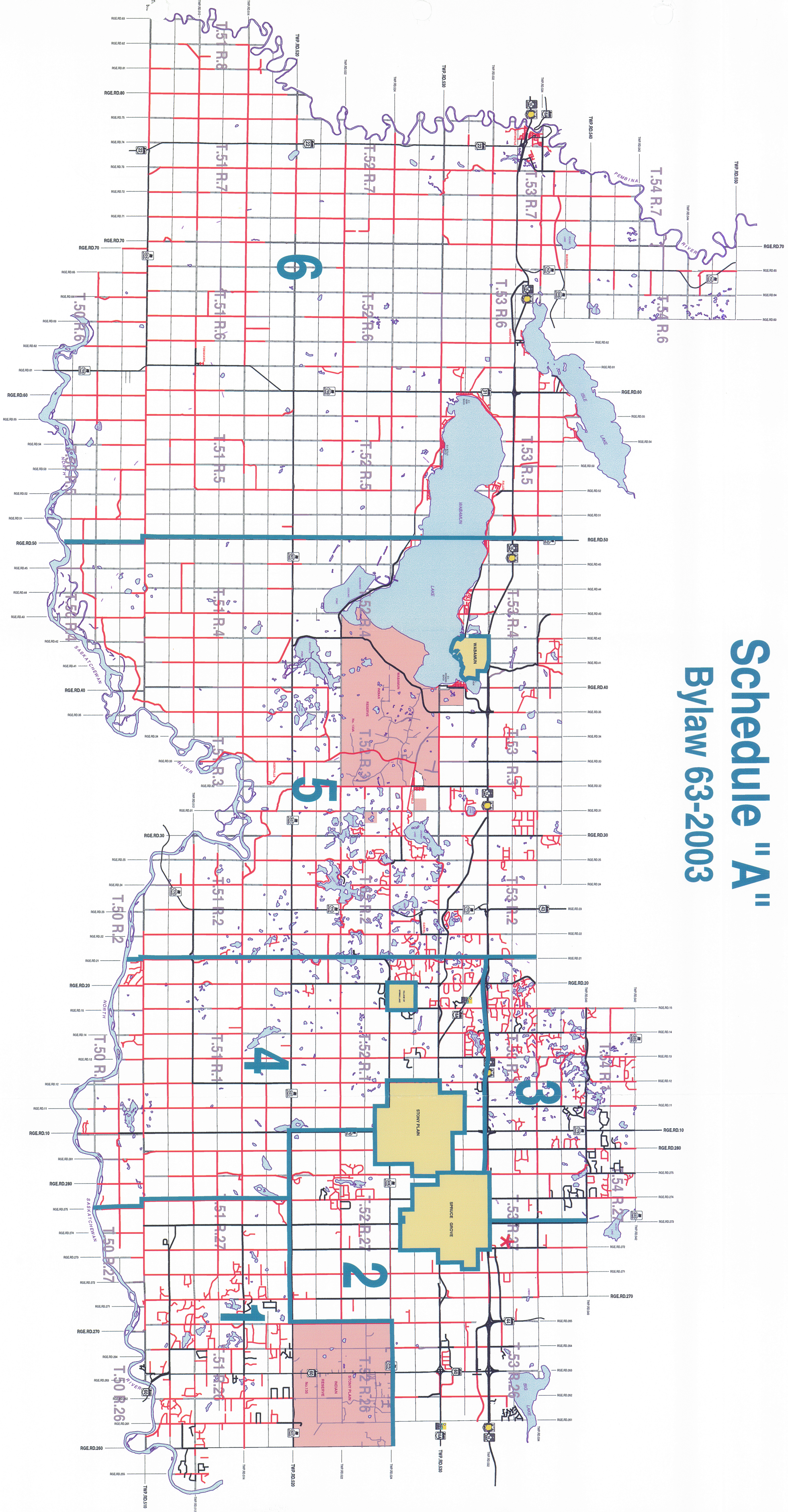
