
Department delivers programs to foster the wellbeing of the environment and agricultural




POTENTIAL RISKS

- Election impacts (federal, provincial, municipal and US)
- Resident buy-in to policy changes and initiatives
- Changes to legislation and regulations
- Reduced future grant funding opportunities
- Increased public expectations higher service level expectations
- Development pressures, new infrastructure and smaller parcels challenging efforts to protect natural areas and prime agricultural land
- Investment in tourism puts pressure on natural systems
- Impacts of climate change on service levels and quality of life
- Public awareness of agriculture




Budgeted Services Expenditures





2026 Environmental Services Budget Expenditure



2026 Environmental Services Budget Revenue





2026 Agricultural Operations Budget Expenditure





2026 Agricultural Operations Budget Revenue





2026 Agronomics Budget Expenditure





2026 Agronomics Budget Revenue





2026 Administration Budget




