BYLAW NO. 2015-37

BEING A BYLAW TO ESTABLISH FEES AND CHARGES FOR THE PROVISION OF GOODS AND SERVICES

WHEREAS pursuant to the *Municipal Government Act* RSA 2000 Chapter M-26, and amendments thereto, a municipality has the authority to establish fees and charges for the provision of goods and services; and

WHEREAS the Council of Parkland County wishes to establish, in a bylaw, certain fees and charges;

NOW THEREFORE the Council of Parkland County, duly assembled and under the authority of the *Municipal Government Act*, as amended, hereby enacts the following:

TITLE

1. This bylaw shall be known as the “Fees and Charges Bylaw”.

APPLICATION

2. This bylaw establishes rates, fees and charges for certain goods and services provided by Parkland County.
3. All fees are non-refundable unless otherwise noted, and all fees include GST unless otherwise noted.

SCHEDULES

4. The fees payable by persons accessing services from Parkland County are those fees set out in the attached schedules described as follows:
 - (1) Agricultural Services – Schedule A
 - (2) Assessment and Financial Services – Schedule B
 - (3) Engineering Services – Schedule C
 - (4) Information Services – Schedule D
 - (5) Planning and Development Services

 - c. Plumbing Permit Fees – Schedule E.3
 - d. Gas Permit Fees – Schedule E.4
 - e. Development Related Service Fees – Schedule E.5
 - f. Subdivision and Related Service Fees – Schedule E.6
 - g. Other Planning Fees – Schedule E.7
 - (6) Enforcement Services – Schedule F
 - (7) Public Works Operations – Schedule G
 - (8) Parks, Recreation and Culture Services
 - a. Meridian Sports Park – Schedule H.1
 - b. Entwistle Pool – Schedule H.2
 - c. Other Parks, Recreation and Culture Fees – Schedule H.3
 - (9) Legislative and Legal Services
 - a. Appeal Fees – Schedule I.1
 - b. General Office – Schedule I.2

BYLAW AMENDMENT

5. That Bylaw No. 1-2003 be amended by removing the schedules as follows:

- (1) Rates and Charges for Wastewater Services Discharging into the Hamlet of Entwistle Wastewater System
- (2) Rates and Charges for Wastewater Services Discharging into the Parkland Regional Trunk Sewer Line
- (3) Rates and Charges for Wastewater Services Discharging into the Hamlet of Tomahawk Sewerage System
- (4) Rates and Charges for Wastewater Services Discharging into the Hamlet of Duffield Wastewater System

And attaching the schedules as follows:

- (5) Entwistle Wastewater – Schedule J.1
- (6) Tomahawk Wastewater – Schedule J.2
- (7) Parkland Regional Trunk Sewer Line (PRTSL) Wastewater – Schedule J.3
- (8) Duffield Wastewater – Schedule J.4
- (9) Water Tariff Rates and Charges from Water Purchased from Parkland County Water Works Systems – Schedule J.5
- (10) Additional Water and Wastewater Fees – Schedule J.6.

6. That Bylaw No. 19-98 be amended by removing the schedules as follows:

- (11) Water Tariff Rates and Charges For Water Purchased from Parkland County Water Works Systems

And attaching the schedules as follows:

- (12) Entwistle Wastewater – Schedule J.1
- (13) Water Tariff Rates and Charges from Water Purchased from Parkland County Water Works Systems – Schedule J.5
- (14) Additional Water and Wastewater Fees – Schedule J.6.

ENACTMENT/TRANSITION

7. Should any provision of this bylaw be deemed invalid then such invalid provision will be severed from this bylaw and such severance will not affect the validity of the remaining portions of this bylaw, except to the extent necessary to give effect to such severance.
8. All schedules referred to in Section 4 shall form part of this bylaw.
9. All schedules referred to in Section 5 shall form part of Bylaw 1-2003.
10. All schedules referred to in Section 6 shall form part of Bylaw 19-98.
11. This bylaw shall come into force and take effect January 1, 2016.

READ A SECOND TIME this 8th day of December, 2015.

READ A THIRD TIME and finally passed this 8th day of December, 2015.
