Introduction

This “What we heard report” has been prepared to summarize the public engagement process, stakeholders involved, and feedback obtained related to Bylaw 2015-09 Animal Control and a potential amendment to allow chickens on parcels of land less than two acres in size.

Public Engagement Objectives

1. To educate targeted residents about urban chickens.
2. To seek feedback from targeted residents on whether they would or would not support an amendment allowing this activity on smaller parcels.
3. To seek feedback from those supporting the amendment what level of oversight and management they would prefer.

Identified Stakeholders

- Residents that own parcels of land less than two acres in size

Methods of Engagement

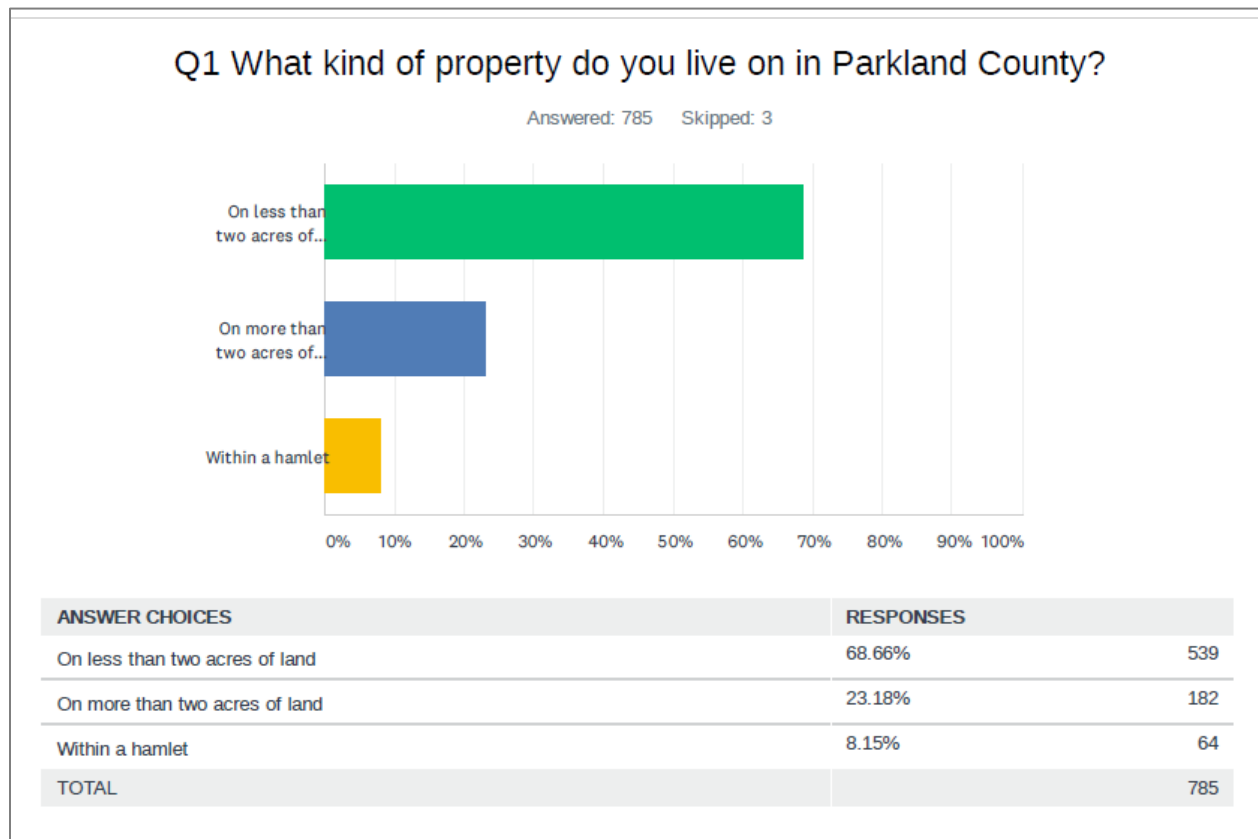
See below for a brief description of each method:

- Webpage
 - A project webpage was set up at www.parklandcounty.com/chickens in early May 2020 to introduce residents to the project and provide educational information and resources on the subject (Appendix A)
- Survey Advertisement
 - Advertisements promoting the survey opportunity and our webpage with further information were published in the Spruce Grove Examiner/Stony Plain Reporter (Appendix B)
- Social Media
 - Advertisements placed on our social media promoting the survey opportunity and our webpage with further information.
- Direct Mailout
 - All property owners of parcels of land less than two acres in size (except for strata type developments ex. Trestle Creek/Pineridge/Parkland Village) were sent postcard invitations to complete survey. Total postcards mailed out – 3,917. (Appendix C)

What We Heard

Administration collected feedback in a variety of ways including verbal feedback, written correspondence, and formal submissions. The key themes shared by stakeholders are summarized below. In addition, Administration has described any action taken as a result of the comments.

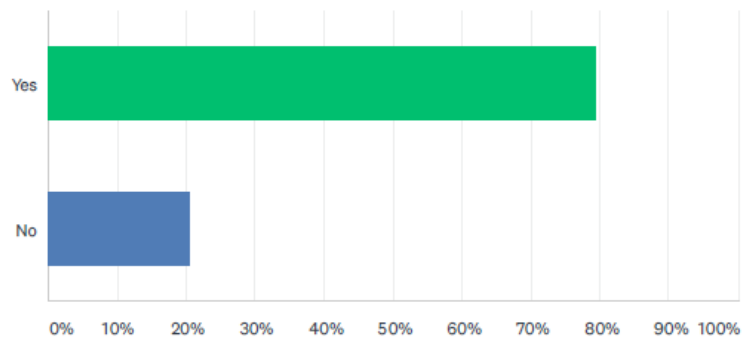
QUESTIONS



- We targeted property owners of land parcels less than two acres in size with our mail outs and advertising
- 77% of respondents own parcels of land less than two acres in size
- For the purposes of the report, we are including all summary data, which includes those respondents who own parcels of land larger than two acres as well
- We have broken out responses by those who own property in Hamlets and those who own property outside of hamlets on parcels of land less than two acres in size
- When comparing responses across all questions the responses are generally the same, any differences are noted

Q2 Do you think chickens should be allowed on parcels of land less than two acres in size in Parkland County (including in Hamlets and multi-parcel subdivisions)?

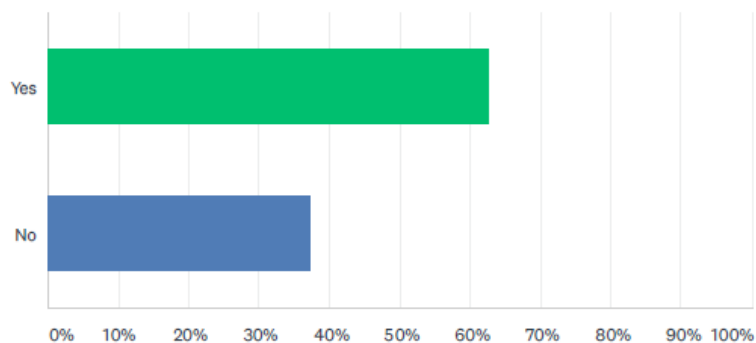

- Overall 79.5% of respondents support allowing chickens on parcels of land less than two acres in size
- 84% support it in Hamlets, 76% outside of Hamlets on parcels of land less than two acres in size

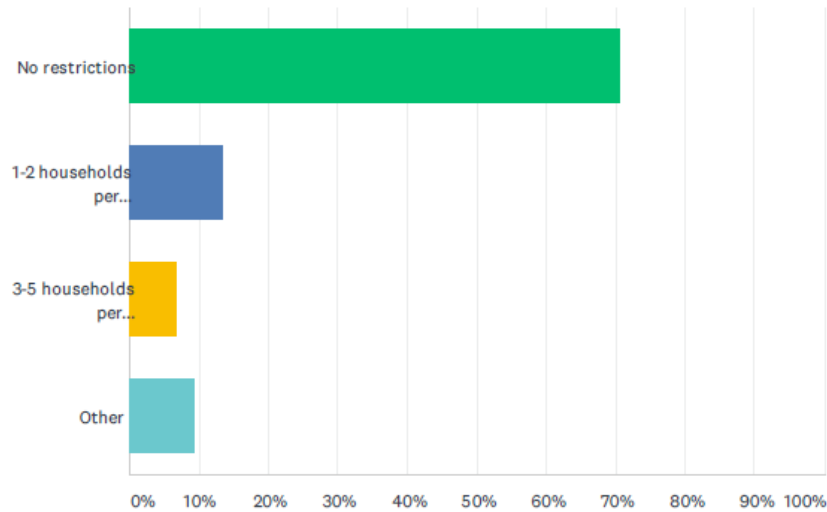

- If allowed 62% overall indicated they would keep chickens
- 67% in Hamlets, 58% outside of Hamlets
- Indicates the potential for a strong uptake on this opportunity if allowed

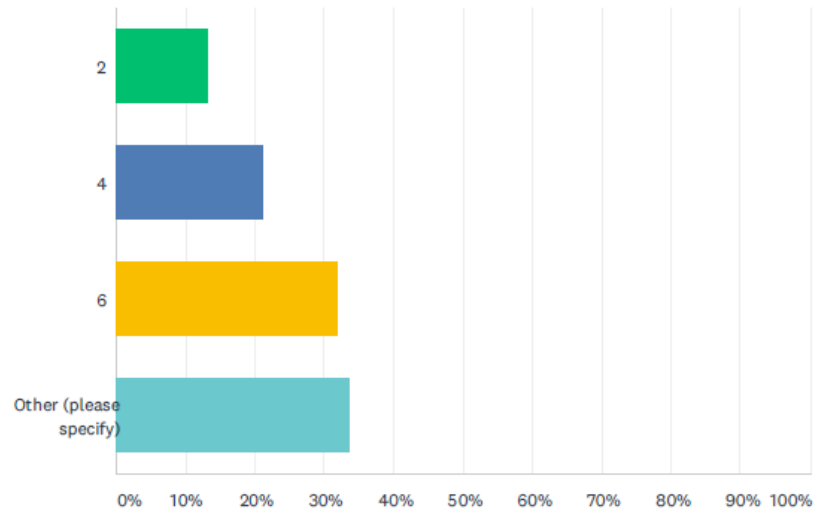

- If allowed 70.6% overall indicated there should be no restrictions on the number of property owners allowed to take advantage of this opportunity
- 75% in Hamlets support no restrictions, 67% outside of Hamlets

Q5 If allowed, how many chickens should people be allowed to keep on parcels of land less than two acres in size?

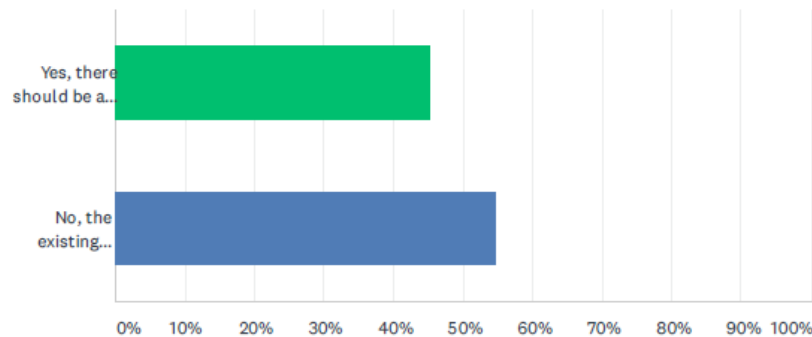

- In terms of the number of chickens allowed 6 was the more popular choice; however the other category response was slightly higher overall with respondents indicating a range from 0 – 50 with the most referencing 8-12 range
- There was a more pronounced separation with Hamlet respondents with 6 being the most selected, but the other category was notably lower indicating that Hamlet respondents may prefer fewer chickens

Q6 If allowed, should there be an associated permitting, monitoring, and enforcement process for keeping backyard chickens?

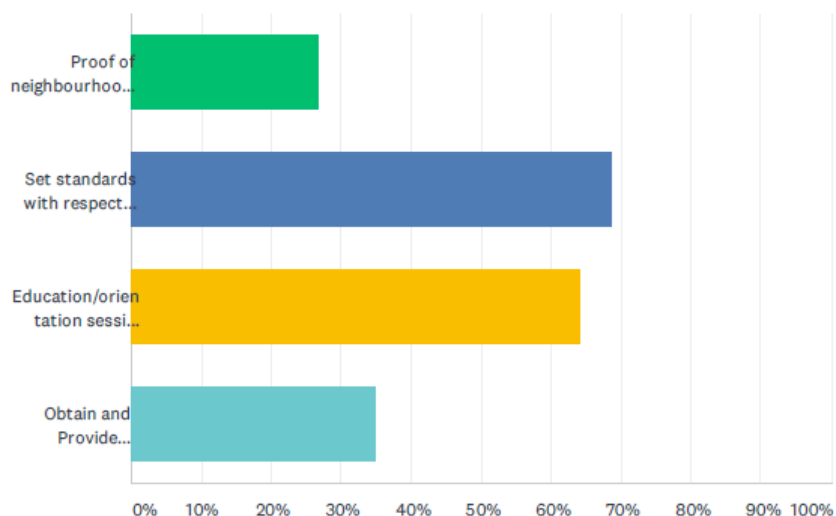

- If allowed respondents, overall, indicated a slight preference for no formalized permitting, monitoring and enforcement process outside of responding on a complaint basis
- The slight preference disappears, and is evenly split 50/50 amongst Hamlet respondents and respondents outside of Hamlets on less than two acres preferring a formalized permitting process vs no formalized process

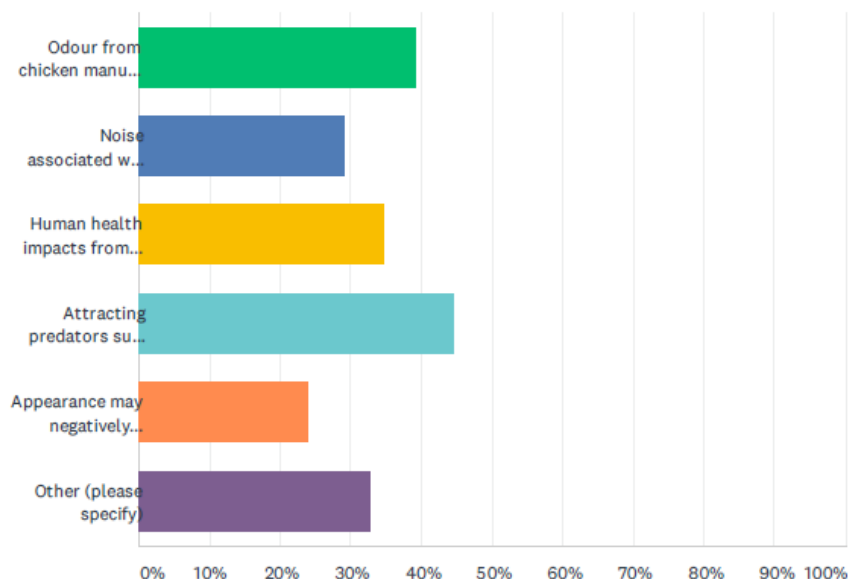

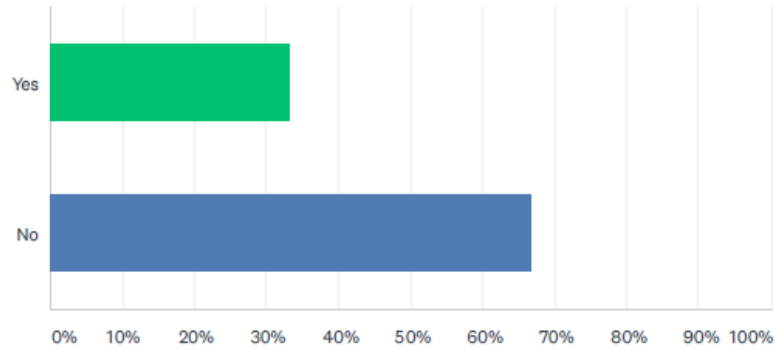

- Odour, Noise, Predators and health impacts were the most common responses when asked what concerns respondents had
- In Hamlets respondents concerns around odour were slightly higher than others, on properties outside of Hamlets under two acres in size predator attraction was slightly higher
- "other" comments included concerns about chicken owners not properly looking after chickens, property value impacts and having no concerns

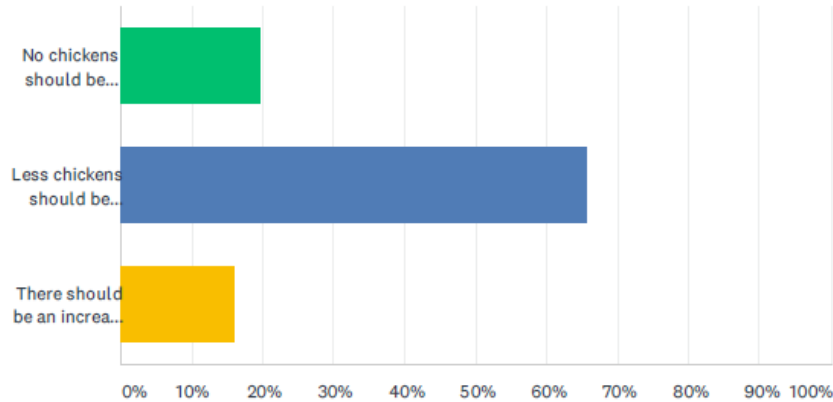

- Overall, just under 67% of respondents indicated that hamlets should be treated the same way as properties outside of Hamlets
- Hamlet respondents were a little lower with 60% of respondents indicated that they should be treated the same way as any other property

 - Advertisements promoting the survey opportunity and our webpage with further information were published in the Spruce Grove Examiner/Stony Plain Reporter
 - Advertisements placed on our social media promoting the survey opportunity and our webpage with further information.
 - All property owners of parcels of land less than two acres in size (except for strata type developments ex. Trestle Creek/Pineridge/Parkland Village) were sent postcard invitations to complete survey.
- **Response**
 - 785 completed surveys received
 - 64 from Hamlets
 - 539 from parcels of land less than two acres
 - 182 from parcels of land two acres or larger
- **Next Steps**
 - Project Team will be reviewing all the feedback gathered and developing options for Committee and Council to consider
 - Report to be brought forth December 2021

The County is revisiting our Animal Control Bylaw in relation to the keeping of backyard chickens to ensure it reflects both current realities along with community values and priorities. We have heard formally and informally from residents who both support and oppose the keeping of chickens.

What is a backyard chicken?

"Backyard chickens" will refer to chickens being kept on smaller parcels of land, less than two acres in size. These are typically within subdivisions and hamlets. In our rural settings, acreages tend to have large, spacious backyards, but the sentiment still applies.

Considerations

If Parkland County were to allow backyard chickens, there are several things to consider, including but not limited to:

- What are the maximum number of chickens and other conditions that we need to consider?
 - Only hens, no roosters
 - Coop/housing standards or requirements
 - Education component requirements
- Should there be adjacent neighbour support before allowance is made?
- Should the County limit the number of properties less than 2 acres in size allowed to keep chickens?
- What might the impacts be of this potential allowance to residents and the Municipality?

Pros

- Therapeutic benefits of having a pet
- Food source
- Can reduce food waste as tables scraps can be fed to chickens
- Waste could be used as fertilizer
- Educational opportunity on agriculture and sustainability

Cons

- Noise
- Smell, animal waste
- Increased predation

- Disease concerns
- Disposal of animals when they become sick or no longer produce eggs
- Associated municipal costs

Where are we at in the process?

We are seeking input from the public on their opinion on keeping backyard chickens. Upon receiving feedback, Administration will present the information to Council, who will decide whether or not changes are required to the bylaw.

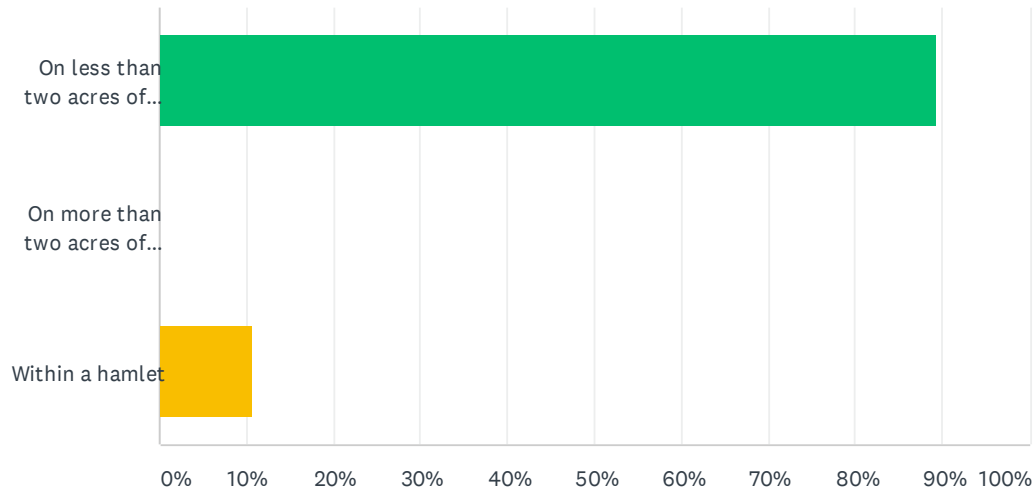

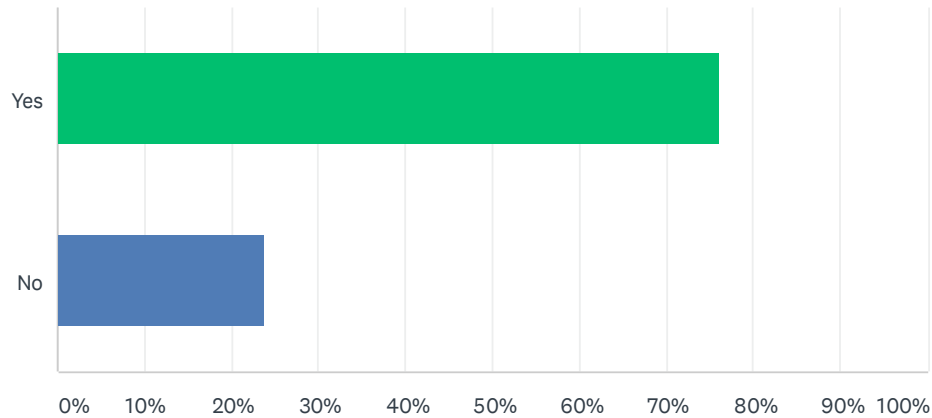

Q2 Do you think chickens should be allowed on parcels of land less than two acres in size in Parkland County (including in Hamlets and multi-parcel subdivisions)?

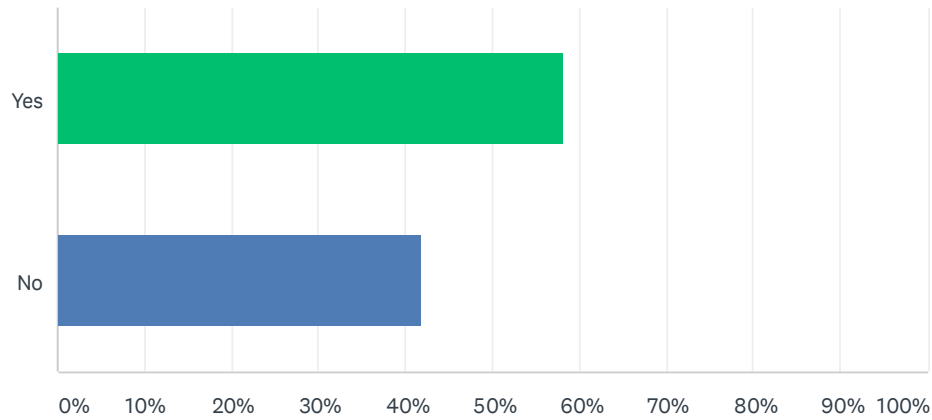

Q3 If allowed, would you keep chickens on your property?

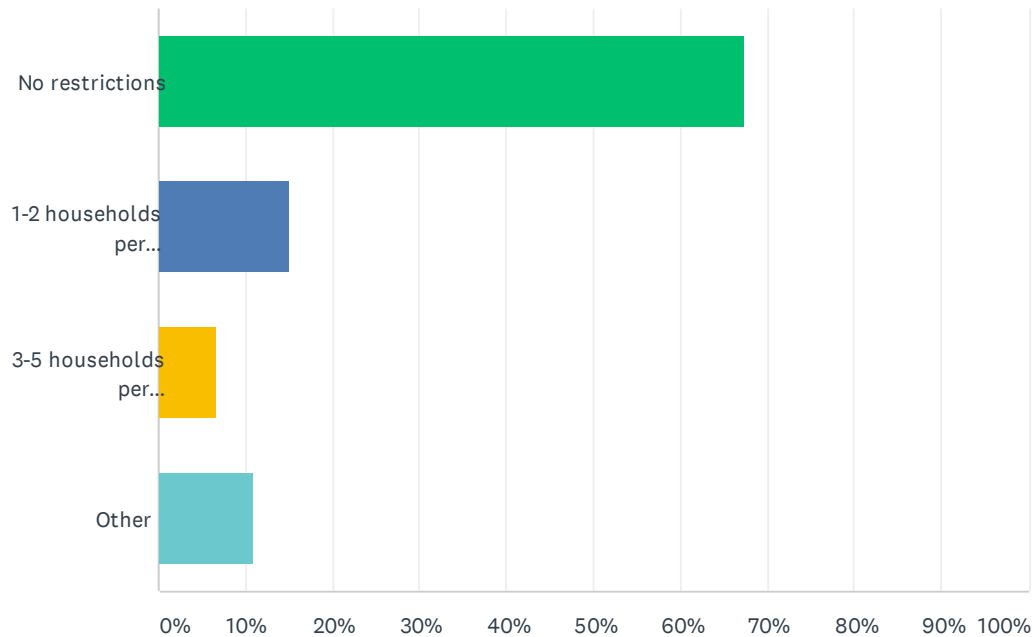

Q4 If allowed, should the County limit the number of households of less than two acres who are allowed to have chickens?

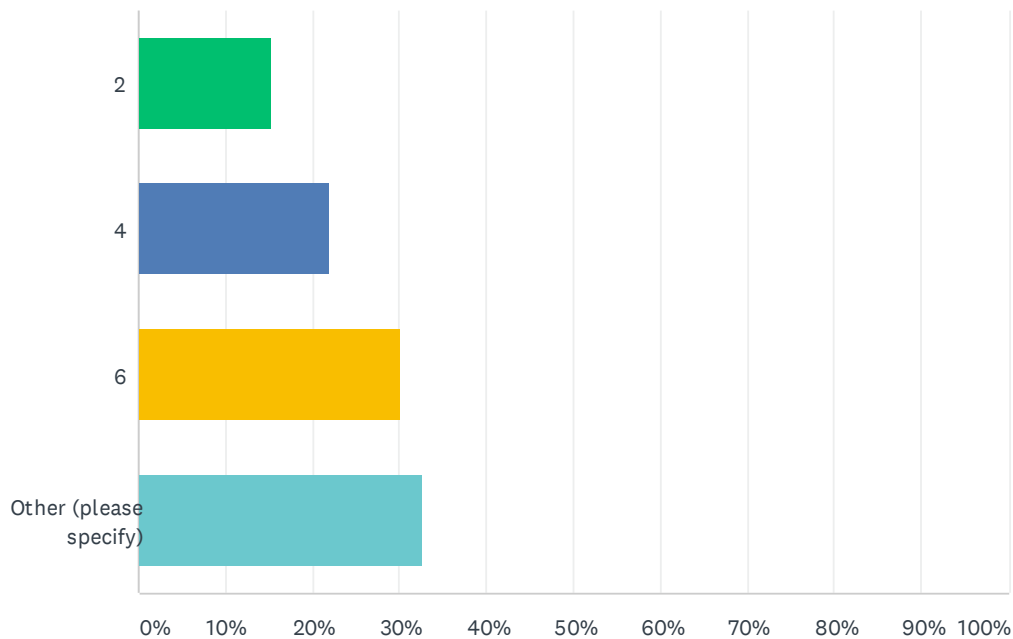

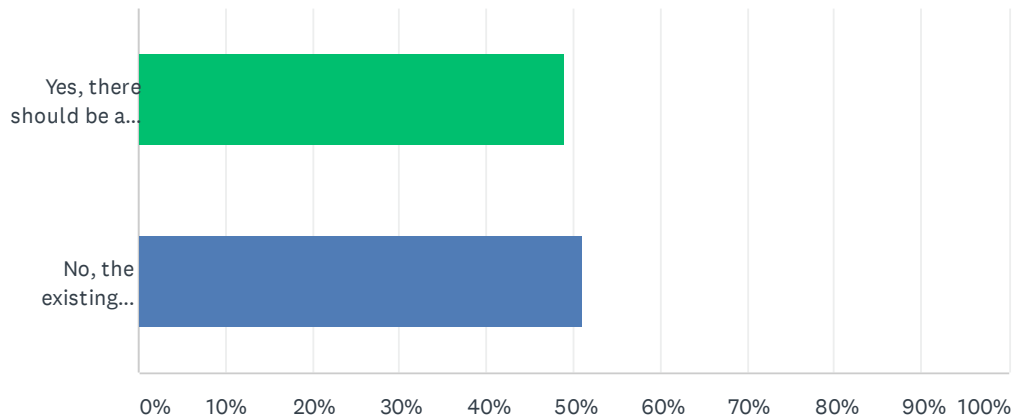

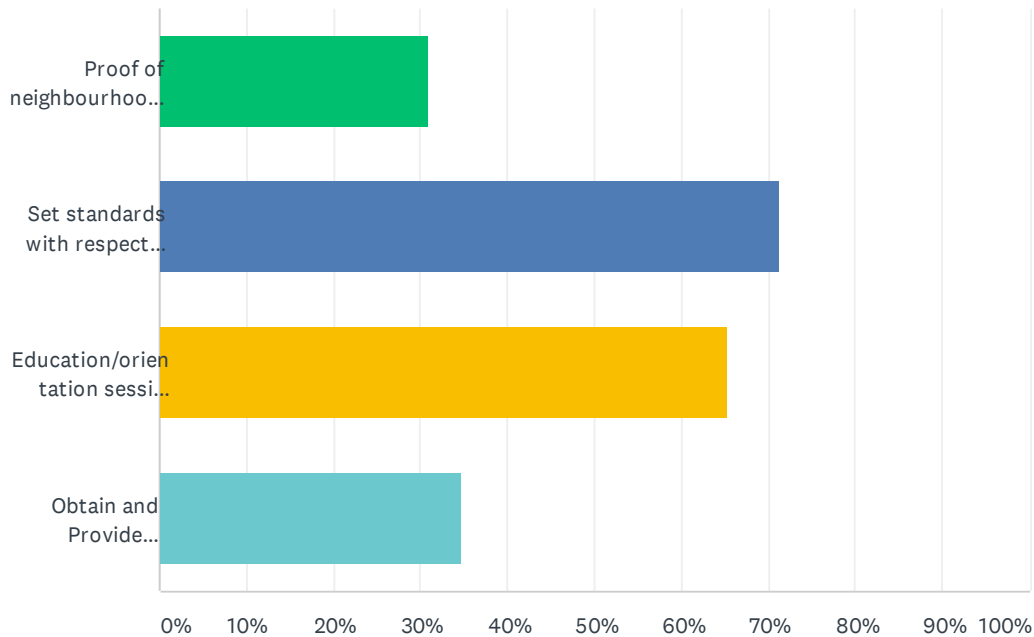

Q7 If allowed, and a permitting process is implemented, what conditions should be considered as part of the application and eligibility process?

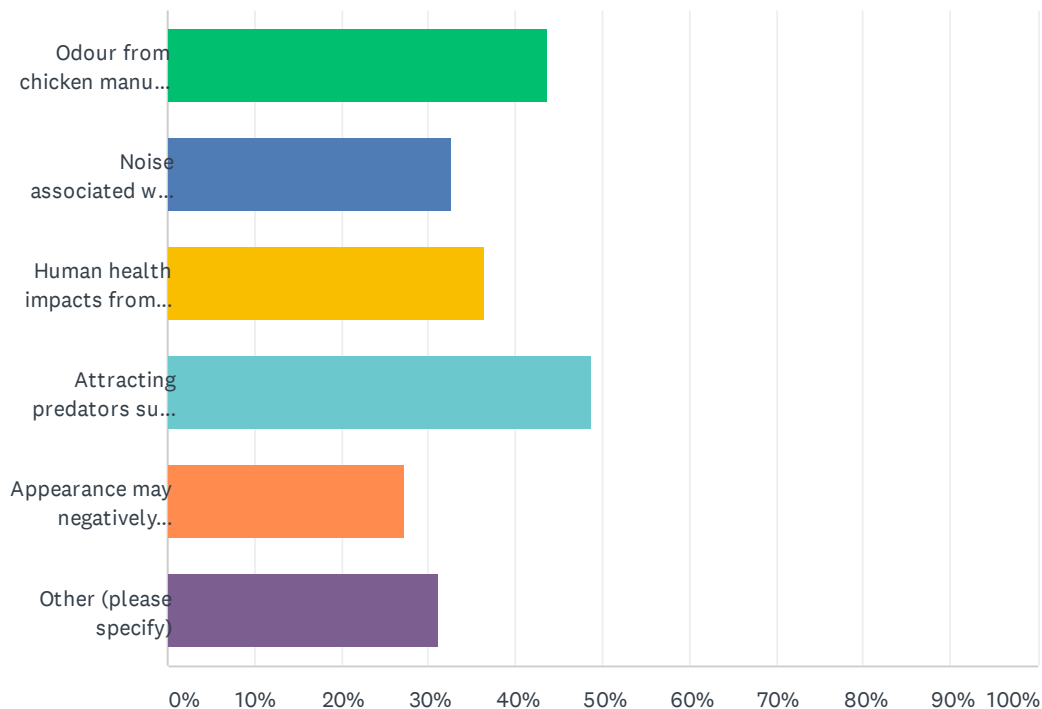

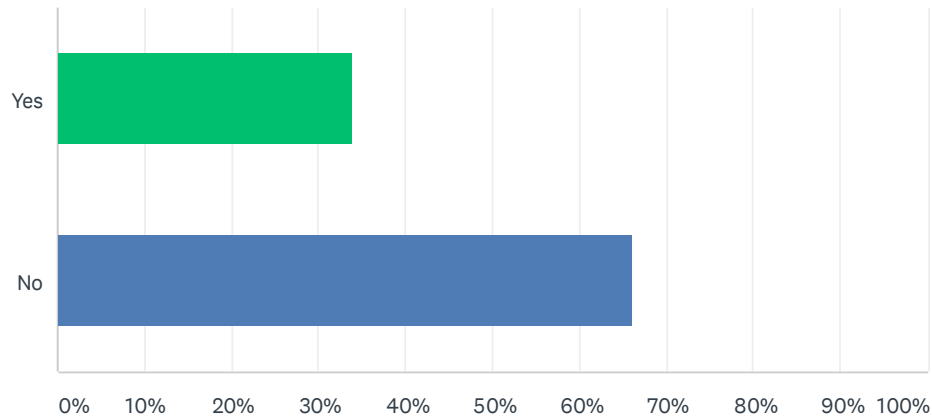

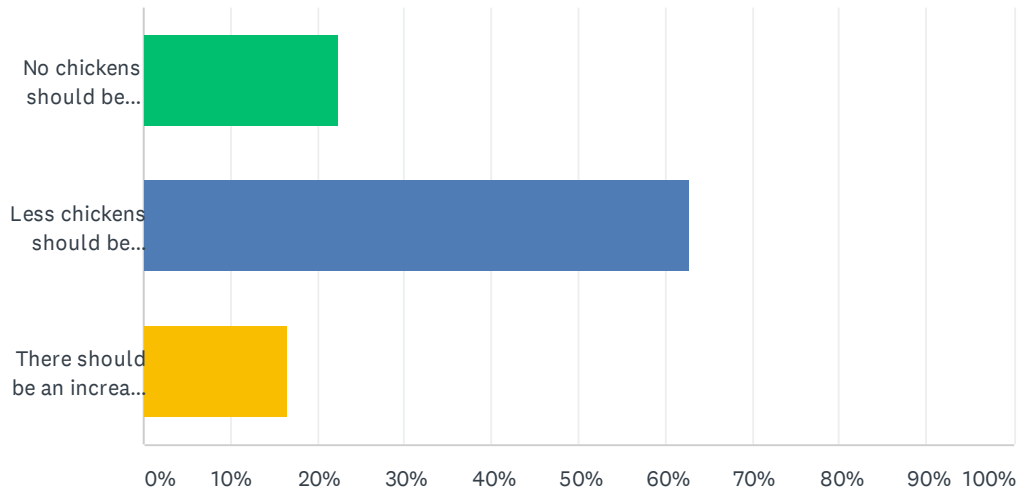

The shavings and manure mix has been amazing for my garden and flower beds and have drastically cut down on food waste in our garbage. The hen house isn't very large but enough room to comfortably house 8 hens. In winter I provide a radiant heat source called a cozy coop instead of a heat lamp to reduce the risk of fire and is easier on the pocketbook. In winter the girls don't stray into the yard but just into the covered run as they don't like the snow. My hen house and run have a footprint of 32 square feet and as no taller than my 6ft fence so is unable to be seen by the neighbours or anyone driving by. I use shavings as it drastically reduces the smell and composts better. In the event of a full flock disease fingers crossed it doesn't happen 1 bird will be sent for a necropsy and the rest will be frozen until informed about proper disposal. I have very little risk of disease as I purchase all my hens from a reputable breeder who fully vaccinates prior to sale. I do not have a rooster as they are noisemakers and I also don't want fertilized eggs nor do I want to hatch out any chicks. I hope this gives you some insight.

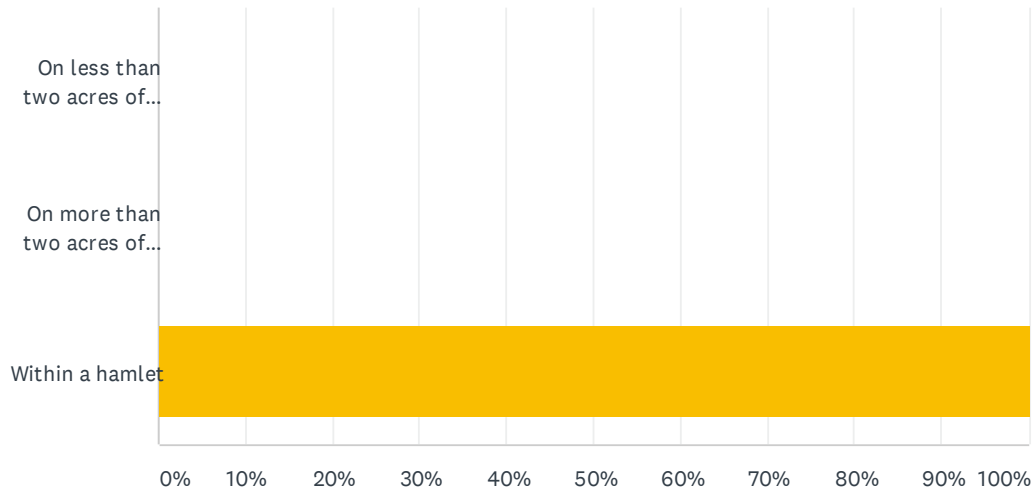

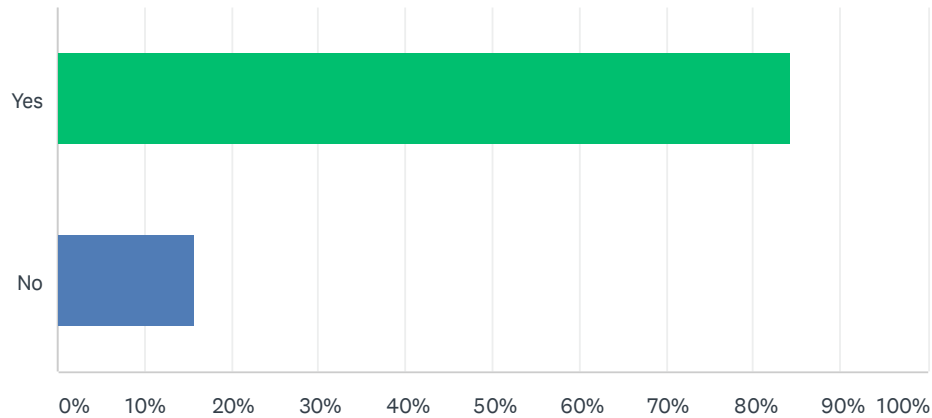

Q2 Do you think chickens should be allowed on parcels of land less than two acres in size in Parkland County (including in Hamlets and multi-parcel subdivisions)?

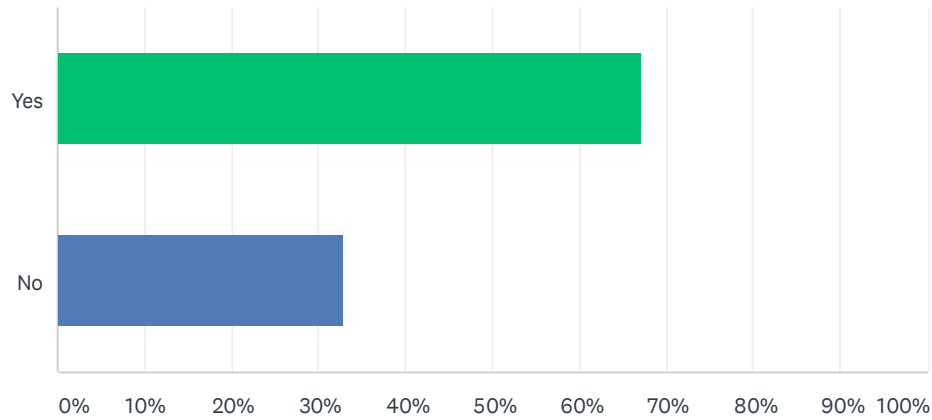

Q3 If allowed, would you keep chickens on your property?

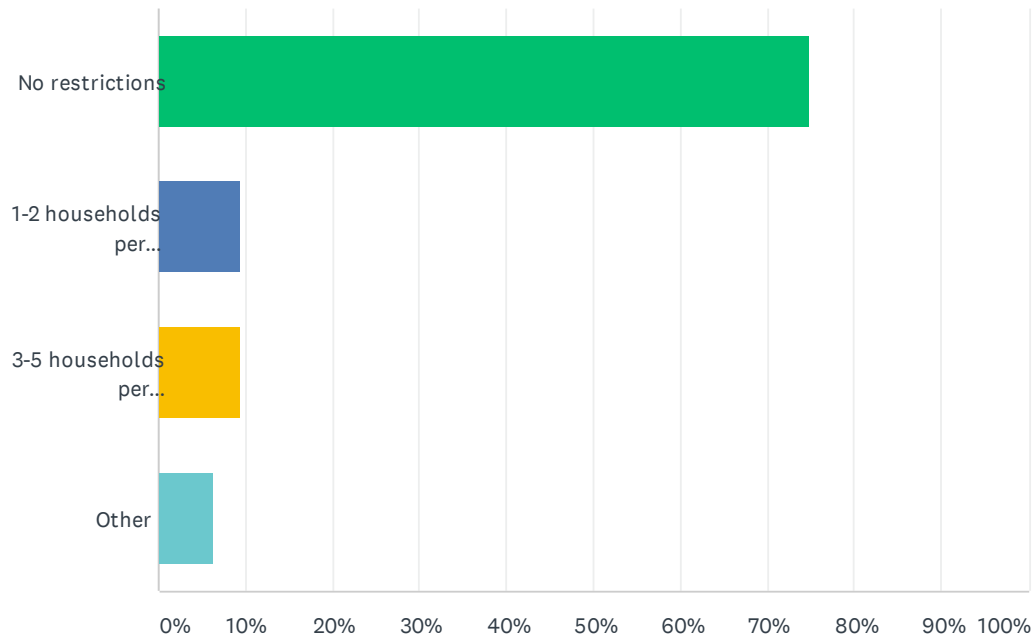

Q4 If allowed, should the County limit the number of households of less than two acres who are allowed to have chickens?

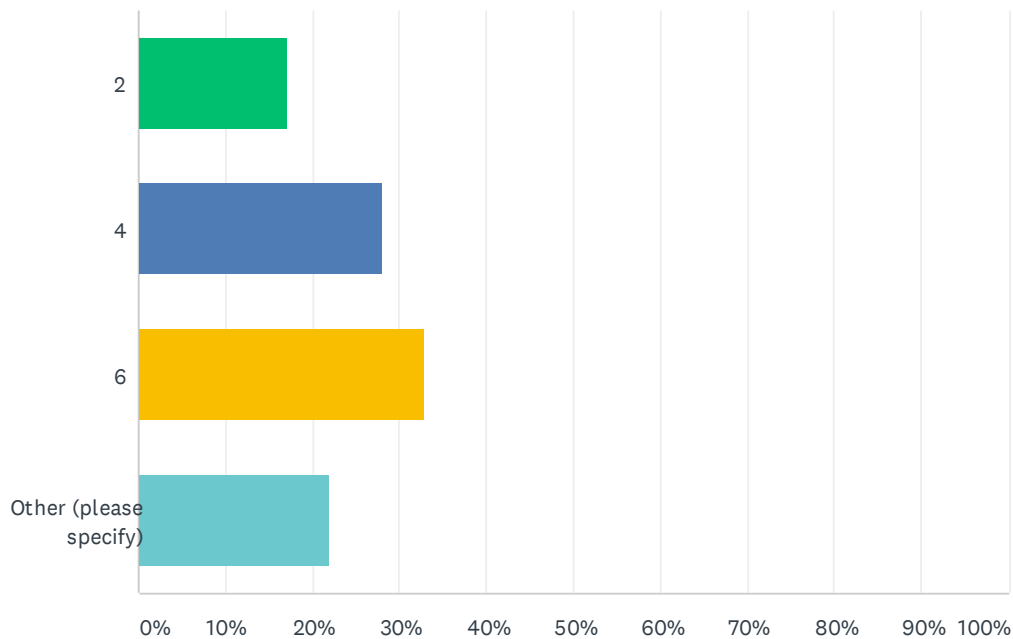

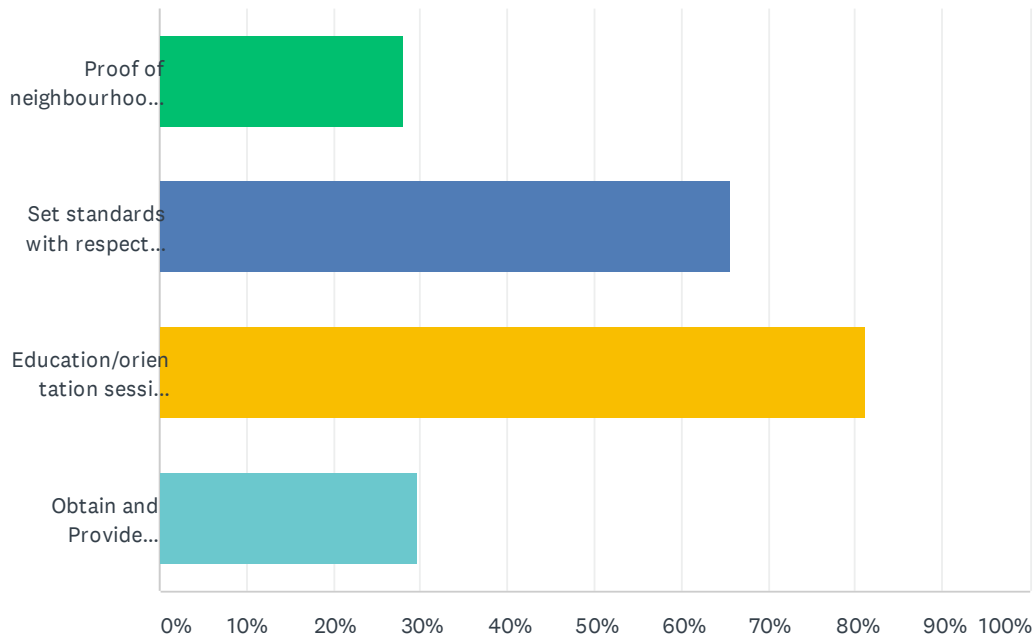

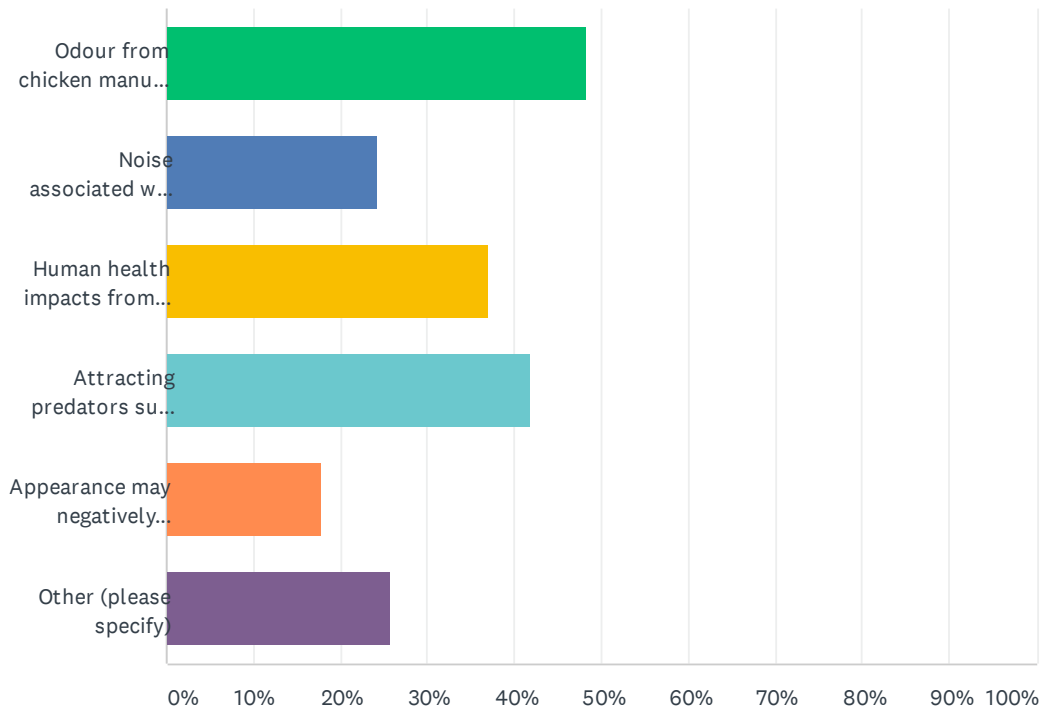

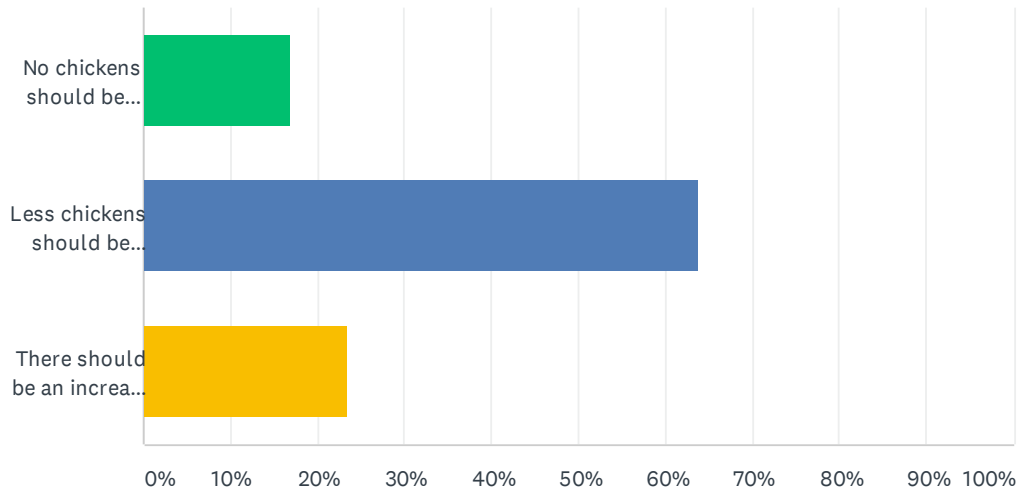
