Re: Spruce Grove Gun Club ("SGGC")

I am writing to express my concern regarding the Parkland County Land Use Bylaw amendment that would exclude outdoor gun ranges from the definition of "outdoor participation recreation and services" in areas zoned for country residential development.

This is unfair, as Parkland County rezoned the area where the Spruce Grove Gun Club (SGGC) is located in 2009, almost 40 years after the club was established.

This affects me personally and it negatively impacts the community.

CFO (Chief Firearms Officer) approved ranges, like the SGGC are, without doubt, the safest places to discharge firearms. The County should consider all safety measures implemented by the SGGC to make up their outdoor gun range. The exclusion of federally regulated outdoor gun ranges only takes away the ability to have a safe place to shoot.

Safety

We share our neighbours' concerns about safety and stray bullets in the area. Over the last few years we have seen dozens of road signs that have been shot and from the damage caused – clearly shot by firearms that are off-range. The bylaws at present allow landowners or anyone given permission by the landowner to discharge a firearm more or less at will. These conditions present safety concerns because of their "lack of regulation."

However, an organized shooting range that fully complies with all the recommendations of the CFO and that has all the safety measures in place provides the safest place in the province to discharge a firearm. In fact, SGGC exceeds mandated requirements in many areas. For example, the height of the berms on the outdoor ranges is nearly four times higher than what is required. Couple this with the fact that people who attend the range are schooled in the correct and safe way to handle firearms means that a well-run range contributes immensely to overall safety of the outdoors.

Noise

The SGGC commissioned professional services to conduct noise evaluations and confirmed they meet county

bylaws. Coupled with that is the frustration that some noise complaints were made when the shooting range wasn't even in operation. It's not our neighbours' fault – it's the safety issue noted above with people shooting guns off-range.

Community

The SGGC is a well-established part of the community having been in the same location for 45 years and a petition organized to campaign to keep the range open has so far garnered over 5,000 signatures of support. As part of the community a number of youth groups from areas both in Parkland County, Spruce Grove, Stony Plain, St. Albert, Edmonton and the wider region use the classroom and shooting ranges. These groups include the 4H club, Junior Forest Wardens and Alberta Fish and Game youth program, Edmonton Police Cadets, Royal Canadian Army Cadets, Royal Canadian Air Force Cadets, and the Royal Canadian Sea Cadets, to name but a few.

The range also forms an integral part of the training and practice of those very people that we as citizens rely on to keep us safe, namely the RCMP, Edmonton Police, The Alberta Sheriffs branch, Brinks, all of whom rely on the range to both train and re-certify when necessary.

The range represents a well-run recreational facility that serves a wide community, so forcing its closure through this bylaw amendment would remove one of a limited number of recreational facilities that are provided and run at no cost to the municipal authorities or to tax payers. Rather than allowing such facilities to close, municipal and county authorities should be promoting groups such as SGGC to provide facilities such as these to the community as they are a win /win situation (a win to the community and a win to the municipal budget).

From a personal note, myself and my partner moved to Spruce Grove almost 2 years ago and shortly after the decision was made to close the range. This upset me as I had hoped that moving to Spruce Grove would allow me more opportunity to practise a hobby. I enjoy benchrest target shooting and moving to where we did as the convenience to access a range nearby was a part of our decision. The time I get to spend at home is minimal due to working in the trades in oil and gas, and even saving almost an hour total driving is much appreciated. The next closest range in the area is the Wabamum Club and Stony Plain Fish and Game Association, which I have been a member of for 3 years. Had the SGGC range not been closed I would have pursued a membership with it.

I hope that you can see that the range is a significant asset to the local and wider community on a number of levels. To close a range that has been a staunch supporter of the local and community for 45 years and that caters to innumerable people who use the facilities, due to unsubstantiated claims and incorrect information, is the height of unfairness.

Please vote against this land-use bylaw amendment. Thank you for your time and I look forward to hearing from you.
