Mayor Shaigec asked the gallery if there were any issues that the public wishes to bring to the attention of Parkland County. The following came forward:

- 1. Steve Zelych, Jackfish Lake area resident, came forward requesting that his neighbor who has a building encroaching onto his property be dealt with by Parkland County in a shorter timeframe than would be allowed so that he may obtain a compliant Real Property Report.
- 2. Richard Whenham, Fallis area resident referred to the Informal Boat Launch at Fallis to be closed as it is a safety matter with lake users launching their boats and parking on the road at this location. Mr. Whenham further requested to restrict access to the area to reduce the traffic.
- 3. Sandy Redmond, Fallis area resident expressed concern that the boat launch was never meant to be used as a public boat launch stated safety concern with the increased traffic and vehicle parking and illegal camping. Ms. Redmond stated that people are using large vehicles to launch and remove their boats, creating an unsightly area and damage to both the road and lake. Ms. Redmond asked that Parkland County immediately close the boat launch access and initiate an environmental review of the lake and for a formal boat launch.
- 4. Manuel Leithoff, Fallis area resident came forward with concern that the boat launch and lake are over used and that Parkland County should take into consideration the feedback of all lake residents and the environmental impact of the damages.
- 5. Sandy Gunderson, Fallis area resident came forward presenting photographs of the boat launch area and the common usage at the site that has created disturbance to the road and lake. Ms. Gunderson requested that an environmental assessment be conducted before moving forward with an informal boat launch to protect the area.
