DELEGATIONS

<u>App 15-050</u> Public Input - 9:15 a.m. (10 mins.)

Mayor Shaigec asked the gallery if there were any issues that the public wishes to bring to the attention of Parkland County. The following members from the public came forward:

1. Melanie Siliphent, Parkland County resident from the Hwy 16 and Range Road 14 area, presented opposition to proposed development in the Hwy 16 and Range Road 14 area as it will increase traffic and create unsafe roads. Ms. Siliphent requested that no development applications be approved by Parkland County for proposed development in the said area.

2. Cliff Spicer, concerned with Parkland County's position regarding a proposed development at Range Road 14 and if the road closes and the traffic flow and how the process has proceeded without the public's knowledge. Mr. Spicer wished for clarification as to the Alberta Transportation waiver and Parkland County's position on this matter.

3. Kevin Worry, requested direction for public to submit their information regarding their concern on the proposed development at Hwy 16 and Range Road 14. Also, concerned that under the conditions of the proposed sudivision development that the public does not have opportunity to appeal the development, but only the applicant has the opportunity to appeal.

4. Corine Lamoureux, Parkland County area resident of Hwy 16 and Range Road 14 concerned with the proposed change to the intersection and referred to Range Road 15 as being a large amount of incidents that occur.

Administration encouraged that public submit comments and concerns in writing to the Parkland County's Planning Services Department.

BL 15-057 PUBLIC HEARING - 9:30 a.m (30 mins.)

Proposed Bylaw No. 2015-27 being a Land Use Bylaw amendment to redistrict approximately 4.04 ha (10.0 ac) of land in the northeast corner of NE 10-53-2-W5M, from the current AGG-Agricultural General District to the RIC - Rural Industrial Commercial District.

Proposed Motions

Upon closing the Public Hearing:

3. That Bylaw No. 2015-27 receive third and final reading.

Mayor Shaigec called the public hearing to order at 9:31 a.m., in accordance with the provisions of the Municipal Government Act, to provide an opportunity for public input and comment regarding proposed Bylaw No. 2015-27, and explained the process of the hearing.

Administration presented Bylaw No. 2015-27.

Verbal Submissions

1. Applicants Frank Florkewich, Lori Florkewich, and Greg Florkewich, support of Bylaw No. 2015-27 to redistrict the subject land to be compliant with the municipal land use bylaw, and that the site is proposed for low traffic volume activity. The established site has had no previous emergency services required.

2. Sharon McGuire, southern neighbor of the subject property, concerned increased traffic and road access, and the environmental impact related to water, noise and general environmental disruption with the proposed commercial sprawl. The subject property has been controversial for regarding commercial use for the past twenty years.

3. Jim and Michelle Stupniski, residents on the east side of the proposed site along Hwy 16 are concerned with traffic on the service road to access 16A that has already increased traffic and is deteriorating.

4 Applicants Frank Florkewich, Lori Florkewich, and Greg Florkewich summarized support for Bylaw No. 2015-27, addressing that the water usage with the proposed commercial development that would be lower than a single family dwelling and there is an existing well on site. The applicants explained that they wish to abide by Parkland County requirements and that Alberta Transportation, who were made aware that the site is to be used to situate show homes on, conditionally approved the application to include line painting and rumble strips; and, that it is not anticipated to generate a large increase in traffic volume.

Written Submissions

 Sharon McGuire, opposed to Bylaw No. 2015-27 for the purpose of a proposed subdivision affecting environment, traffic increase, and property value decrease.
 Michelle Stupniski, opposed to Bylaw No. 2015-27 that the rezoning for a proposed subdivision would increase traffic, road dust issues, noise, potential for property value to decrease.

Mayor Shaigec closed the public hearing at 10:04 a.m.

Mayor Shaigec called the public hearing to order at 10:17 a.m., in accordance with the provisions of the Municipal Government Act, to provide an opportunity for public input and comment regarding proposed Bylaw No. 2015-13, and explained the process of the hearing.

Administration presented Bylaw No. 2015-13.

Verbal Submissions

1. Russ Orchanis, Fallis area resident, concerned with the recreation vehicle use portion of Bylaw No. 2015-13 along the lake and the current lack of recreational vehicle control on the property that exacerbate the lake, and that recreational vehicles are not taxed the same as structures on lake lots.

2. Gary Harschak, Fallis area resident, opposed to recreational vehicle parking on property that generate over crowding, increased traffic and noise, and concern with environmental protection.

3. Patty Helten and James Fasek, Jackfish Lake Management Association referred to their written submission in support of Bylaw No. 2015-13 in order to successfuly manage and protect the environmental resources lakes.

5. Walt Neilson, Mayatan Lake Management Association, supports Bylaw No. 2015-13 to conserve the water quality in Parkland County.

5. Mike Fin, Ascot Beach resident, concerned with existing pump-out services on recreational property and concerned that the public was not made aware of the proposed Bylaw.

6. Gary Mastervick, Ascot Beach area resident, opposed to Bylaw No. 2015-13

because long term recreation vehicle parking will be perhibited.

Written Submissions

1. Brian and Donna Steffler, opposed to Bylaw No. 2015-13 as presented, and requests that the bylaw address the permissible use of recreational vehicles in recreational areas such as lake lots.

2. Bev and Neil Steffler, opposed to Bylaw No. 2015-13 as presented, and request that the bylaw outline the various recreational vehicle uses situated on recreational property or residential property.

3. Patty Helten, JLMA Environmental Committee Chair, supports Bylaw No. 2015-13 to encourage recreational vehicle users to remove their unit from the site to empty their grey water, and provides better control of lake capacity issues.

Mayor Shaigec closed the public hearing at 11:17 a.m.
