Note:

Bylaws 2017-03 and 2017-04 are two separate bylaws but are intended to be heard within the same Public Hearing as they are related and the information presented is pertinent to both agenda items. It is recommended the the Chair open the Public hearing for both agenda items at the same time.

Second and third readings of each Bylaw should be done separately (see recommended sequencing below).

1. Chair calls Hearing to Order. For Bylaws 2017-03 and 2017-04

- 2. Chair advises that this is a formal Hearing and records are being kept of the proceedings.
- 3. Chair states following purpose of the Hearing:

"In accordance with the Provisions of Section 692 of the Municipal Government Act, as amended, the Council of Parkland County is holding this Hearing to provide an opportunity for public input and comment on proposed Bylaws 2017-03 and 2017-04."

- 4. Chair then outlines Hearing Procedures as follows:
 - a) Council will first hear an overview and summary of the proposed amending Bylaws from Administration as well as any written submissions received prior to the hearing;
 - b) Council will then receive any additional written or verbal submissions from the floor. Those who wish to speak must first identify themselves and address their comments to the Chair. There will be an approximately 10-minute limit on the length of verbal submissions or presentations. Council may ask for any clarification on written or verbal submissions at any time. Council wishes to remind everyone that this will be the only opportunity to comment on this proposed Bylaws; and
 - c) following the verbal presentations Administration will respond to any questions from Council.
- 5. Chair asks Council if they are satisfied with the information received before closing the hearing and advises that if Council wishes to obtain more information, a motion to recess the hearing may be made at this time.
