**BYLAW 2017-18
A BYLAW TO REGULATE LAND USE WITHIN PARKLAND COUNTY**

WHEREAS under the authority and subject to the provisions of the Municipal Government Act, R.S.A. 2000, c.M-26, and amendments thereto, the Council of Parkland County must pass a land use bylaw; and

WHEREAS the Council of Parkland County has passed Bylaw No. 20-2009 as the County’s land use bylaw; and

WHEREAS Council deems it desirable to replace Bylaw No. 20-2009; and

NOW THEREFORE the Council of Parkland County duly assembled and under the authority of the Municipal Government Act, as amended, hereby enacts the following:

TITLE

- 1. This bylaw shall be known as the Parkland County “Land Use Bylaw”.

INTERPRETATION

- 2. The headings in this bylaw are for reference purposes only.

LAND USE BYLAW ADOPTION

- 3. Schedule “A” is hereby adopted as the Parkland County land use bylaw.
- 4. This bylaw applies within the geographical boundaries of Parkland County.

ENACTMENT/TRANSITION

- 5. Should any provision of this bylaw be deemed invalid then such invalid provision will be severed from this bylaw and such severance will not affect the validity of the remaining portions of this bylaw, except to the extent necessary to give effect to such severance.
- 6. Schedule “A” forms part of this bylaw.

- 8. This bylaw shall come into force and take effect on the day of third reading and signing thereof.
