**BYLAW 2018-06**

**BEING A BYLAW TO ESTABLISH FEES AND CHARGES FOR THE PROVISION OF GOODS AND  
SERVICES WITHIN PARKLAND COUNTY, IN THE PROVINCE OF ALBERTA**

**WHEREAS** pursuant to the *Municipal Government Act* RSA 2000 Chapter M-26, and amendments thereto, a municipality has the authority to establish fees and charges for the provision of goods and services; and

**WHEREAS** the Council of Parkland County wishes to establish certain fees and charges;

**NOW THEREFORE** the Council of Parkland County, duly assembled and under the authority of the *Municipal Government Act*, as amended, hereby enacts the following:

**TITLE**

1. This bylaw shall be known as the “2018 Fees and Charges Bylaw”.

**APPLICATION**

2. This bylaw establishes rates, fees and charges for certain goods and services provided by Parkland County.
3. All fees are non-refundable unless otherwise noted, and all fees include GST unless otherwise noted.
