KEY PERFORMANCE INDICATORS

Planning & Economic Diversification

Total number of Building Permits Issued

- As of August 31st: **363**
 - 2013-2017 year to date average: 470

Construction Building Permit Value

- As of August 31st: \$90M
 - 2013-2017 year to date average: \$103M

Safety

- Total Recordable Incident Frequency (12-month rolling)
 - -3.91

- Turnover rate: 13% (January- September)
- Recycled Material Diversion: 38% in 2017
- Salaries, Wages & Employee Benefits as a percentage of total municipal operating costs
 - 2017 Year End

Public Works

- Increased road maintenance service levels
 - -5,800 pothole repairs, 9.6 kilometers of shoulder pulling and 19.4 kilometers of surface overlays.
 - Pothole patching and road repairs on main arterial roads are close to completion, and 75% complete in sub-divisions.
 - With normal weather patterns in the fall, Parkland County roads should be in reasonable driving condition.
- Other key accomplishments
 - Received approximately 20% less public concerns on road conditions, over same time period in 2017.
 - 55,000 customers served at the Parkland County Transfer Station (January-August)
 - Completed the Mobile Equipment Lifecycle Plan review and implemented recommendations.



 - Design to be started in Q3/Q4 2018
 - Asphalt Overlays Program complete

 - Twp 533A Projected completion Oct 2018
 - Twp 532A Project complete

Engineering Services

Other

- Aggregate compliance review initiated in September 2018. Anticipated completion in November 2018
- Storm Operations & Maintenance Analysis initiated in September 2018. Atrisk for full project completion by end of 2018 but will be completed early in 2019 if additional time is required.
- Gravel Pit Reclamation, Stripping and Brushing
 - →Reclamation Activities in Bamber Pit & Brightwood Pit
 - →Complete brushing /stripping in Bamber Pit
 - →Anticipated completion by October 2018



Planning and Development

- Land-Use Bylaw Refresh is ontrack
 - Phase 1 and 2 complete; Phase 3 will be complete by Q4
- Intermunicipal Development Plans and Intermunicipal Collaboration Frameworks:
 - Brazeau: ICF and IDP approved by both Councils July 2018.
 - Yellowhead: Final approvals by early October 2018.
 - Lac Ste. Anne: Final approvals by late October 2018.
 - Spring Lake: Final approvals by end of December 2018.
 - Summer Village Betula Beach: Final approvals in February 2019.



Economic Diversification

- Economic Diversification Strategic Action Plan under development
- Industrial land needs analysis complete
- Developer workshop series complete
- Champion Petfoods- Construction well under way. Completion targeted for august 2019.
- Pinnacle- Construction 95% complete. Production has started.
- There has been a substantial increase in the number of Industrial and commercial projects being worked on with Economic Diversification.



Community Sustainability

- Watershed Land Use Plan Implementation (Lakes)
 - Ongoing participation in watershed alliances.
 - Project funding was secured for natural capital assessment of Modeste subwatershed.
 - Integrated Watershed
 Management Plan for the
 Sturgeon River Watershed
 under development.



Environmental Compliance

- Many small non-compliances have been rectified.
- Four major non-compliances that will require mitigation have been identified.
- Also includes ongoing contaminated sites identification.
- Currently reviewing responses to RFPQ for environmental assessments



Community Sustainability

ALUS

 Ongoing project implementation. Hosting a 1000 acre party and tour September 27 and Beavers on the Landscape workshop in November. The PAC has approved 21 projects in 2018 thus far.

Green Acreages

- Ongoing project implementation. Received \$20,000 grant.
- Mail out to engage eligible residents delivered early Sept.
- Partnered with Love Your Lake program at Lakes Wabamun and Isle.
- Have had 29 applications and 10 approved projects in 2018 thus far.

Wabamun Lake Ice Heaves

 Work plan for restoration approved by Council in June. Plans for sites nearly finalized. Contractor hired to complete earthwork by end September. Planting to be completed early October. Council update in October.



Hamlet Strategy

- Working with Council and Council Committees to identify strategic components:
 - Critical success factors to rural revitalization
 - Broad objectives.
- Internal steering committee is finalizing:
 - Proposed service level standards
 - Needs Assessment
 - Funding Model & WorkPlan

Smart Parkland

- Action Plan accepted by Council February 2018; now onto implementation
- Civil work near complete on Fibre build
- Smart Cities challenge
 - In process of selecting consultants for 5 areas of the strategy
 - Eligible for \$10 million prize



CORPORATE SERVICES

Legal Services

- Many departments are now using the records management software to manage paper, and in some cases electronic, documents
- At July 3rd there are over 81,000 records in the software including 43,000 electronic documents and emails.
- 24 formal procurement (tender) documents have been issued at the end of June 2018
- Land Administration function at the County is currently under review by a group of directors

Information Management

- Enterprise Resource
 Planning system upgrade
 on track
- Council Chambers AV replacement complete
 - Will be looking at video system for late 2018

- Significant focus on leadership development for 2018
- New performance program initiated and underway.
- Safety Awards, STARS Awards & Innovation Awards programs launched in April 2018.
- Improvements made to onboarding and orientation
- Respectful workplace review underway

 - Program under reconstruction to better connect the workforce to safe work and create a safety culture.
 - Safety Day held with positive results.
 - Observation/Intervention cards becoming more meaningful and behavioural based.

- Phones and back up 911 lines have been installed at the Acheson Fire Station.





FIRE SERVICES – Q2 INCIDENT DATA


Quarter 2 Comparison of Total Incident Activity – Incident that have occurred in Parkland County






INCIDENTS BY LOCATION

Q2 INCIDENT BY AREA, BY TYPE




