PURPOSE

The purpose of this policy is to acknowledge and provide recognition to Parkland County residents, proups, organizations, businesses and schools who have distinguished themselves through significant achievements.

POLICY STATEMENT

Parkland County Council shall make award presentations to eligible County residents to acknowledge and recognize their outstanding achievements in Arts and Culture, Athletics, Agriculturale, the 100-Year Agricultural Farm Family Award, and Community Life, Sustainability, and the Agricultural Bursary through the Awards of Excellence Program, Parkland County Council shall present a Sustainability Award to eligible County residents to acknowledge, and recognize their outstanding contributions to increasing Parkland County's sustainable livability.

DEFINITIONS

- "Arts and Culture" refers to outstanding individuals or organizations who gain provincial, national or international acceptance or recognition of outstanding achievement in one or more of the arts where considerable discipline, skill and training is required or where qualified board adjudicators or judges have publicized their awarding opinion or decision) an artistic or cultural event including, but not limited to, fine arts,drama and dance, where distinctive placings are awarded, i.e., one first, second and third.
- 2. "Athletics" refers to outstanding provincial, national and international calibre athletes who have represented Parkland County in a creditable manner in athletic competition and whose example of good sportsmanship has brought repute to the sport and high regard for the individual an amateur athletic endeavor or competition which is recognized by a sanctioned provincial, national or international governing body and must award distinctive placings, i.e., one first, second and third.
- "Agriculturale" refers to outstanding individuals or organizations who gain provincial, national
 or international acceptance or recognition of outstanding achievement in an agricultural
 discipline or sector where qualified board adjudicators or judges have publicized their awarding
 opinion or decision, an agricultural event or occurrence where distinctive placings are awarded,

i.e. one first, second and third. Also included in this category is the Northlands Farm Family recipient as awarded to one Parkland County farm family in even numbered years.

- "100 Year Agricultural Farm Family Award" refers to the award presented to those farm families
 who have farmed, and continue to farm; in Parkland County for 100 years or longer.
- 5. "Community Life" refers to an outstanding individual (s) who has made a significant and/or lifetime contribution to the community which enhances the quality of life in Parkland County. Nominees may be recognized for a single action or for a contribution or achievement over an extended period of time.
- **6.** "Agricultural Bursary" refers to 5 (five) \$500 awards given to up to 5 post-secondary students who are enrolled in an Agriculture-related program.
- 7. "Sustainability" refers to individuals or organizations who are meeting the needs of the present without compromising the ability of future generations to meet their own needs. Nominees are committed to sustainability and stewarding our natural environment and fostering a sustainable and diverse economy while maintaining our rural character. They are innovative and creative in growing a healthy community that provides equitable opportunities for all, and celebrate our heritage and culture. This is in keeping with the Integrated Community Sustainability Plan (ICSP). (Integrated Community Sustainability Plan (ICSP). (Integrated Community Sustainability Plan (ICSP).)
- "Residents" refers to individuals that have resided in or owned property in Parkland County for at least one (1) year.
- "Business" refers to an entity engaged in commerce and is physically located within the municipal boundaries of Parkland County.
- 10. "Groups or Organizations" refers to an organized body of people with a particular purpose based in Parkland County where the majority of members live in the municipal boundaries of Parkland County.
- 5.11. "School" refers to any educational entity that is part of Alberta's K to 12 education system and is located within the boundaries of Parkland County, City of Spruce Grove and Town of Stony Plain. Schools are eligible to enter the Sustainability Award category only.

ELIGIBILITY

- . Any current resident of Parkland County is eligible.
- Former residents may receive awards provided they are being nominated for achievements or contributions that took place at the time they lived in the County, and that they have lived in the County within the last three years.
- Individuals who live in Parkland County and participate in groups not based in the County are eligible to receive awards as individuals.
- . Nominees may be professionals, amateurs or volunteers.
- Parkland County, employees are not eligible to receive an award recognizing their work at the County. One exception: If the employee, as part of their County role, is a member of a community organizing committee (e.g., hosting a large event), they may be recognized as part of that group.

This policy applies to all Parkland County residents who meet the required criteria for the Awards of Excellence Program.

RESPONSIBILITIES

The Chief Administrative Officer (CAO) oversees the implementation of the Awards of Excellence Program. Community Services is responsible for the oversight of the Awards of Excellence Program.

STANDARDS-(Optional)

 Parkland County Council will present Awards of Excellence to eligible County winners in each award category upon recommendations made by:

A. The Community Sustainability Committee for the categories of

i. Arts & Culture

ii. Athletics

iii. Community Life

iv. Sustainability

B. The Agricultural Service Board for the categories of

i. 100 Year Farm Family

ii. Agricultural Award

1-iii. Agricultural Bursaryresidents at Council meetings throughout the year as recipients are nominated.

Parkland County will not formally recognize nominations as a result of competitions occurring within the school system, and will refer these to their respective school boards for consideration.

Awards of Excellence will be presented to recipients at an event during the month of June.
