- 1. To identify the services required to support the goals of and to implement the Growth Plan;
- 2. To support the optimization of shared services to enhance use of ratepayers dollars;
- 3. To facilitate orderly, economical and environmentally responsible growth in the Edmonton Metropolitan Region;
- 4. To coordinate planning and decisions regarding services among member municipalities to ensure the optimization of rate payer dollars

## **Contents** of the Servicing Plan

### The Servicing Plan must

- List the servicing required to support the development outlined in the a) Growth Plan, which may include
  - i) transportation including regional transit
  - ii) water, waste water, and storm water
  - iii) solid waste
  - iv) emergency services, and
  - v) any other services identified by the Board which benefit residents in more than one of the municipalities that are part to the servicing plan
- For services provided on an intermunicipal basis; outline how it will be b) delivered and inter municipally funded
- Set the time frame for implementing services to be provided inter C) municipally
- Other matters necessary to support the Growth Plan d)






## **MRSP** Intent

- Structured approach and process for ongoing regional collaboration of metropolitan servicing
- MRSP Standing Committee to lead alignment of the MRSP with the **Growth Plan**
- Four Regional Collaboratives Stormwater, Solid Waste, Fire/EMS and **Emergency Management**
- MRSP Principles to guide information sharing, evidence-based decision-making, and prioritization of regional investments
- A framework for accountability and reporting to the EMRB on the MRSP ightarrow

## What the MRSP is not ...

- A plan for all metropolitan services
- Replacing many important and effective local and sub-regional plans or planning and service delivery entities
- A plan to define services nor service levels for the diverse rural and urban communities
- A plan that defines future local capital and operating plans for infrastructure investment
- A replacement for many important and effective initiatives by regional stakeholders and partners

## **MRSP** Principles

- Leverage sub-regional service initiatives to the benefit of the Region
- Recognize the unique urban and rural service contexts
- Factor in the safety and wellness of citizens
- Measure and report results from servicing efficiency and effectiveness
- Act in a regional manner with a unified voice
