Purpose

The purpose of proposed Bylaw 2018-21 is to amend Land Use Bylaw 2017-18, Section 18 - Enforcement. The amendment will strengthen the Land Use Bylaw as it relates to land use enforcement by providing clarity and establishing set penalties related to land use offences.

Summary

This amendment is part of a larger land use bylaw strategy ensuring the document remains relevant and effectively responds to enforcement issues.

The *Municipal Government Act* gives municipalities their authority to enforce municipal law and impose penalties. The proposed amendment integrates the *Municipal Government Act* into the Land Use Bylaw as it relates to enforcement and incorporates specified penalties.

The proposed Bylaw addresses land use enforcement specific to legislation in the Municipal Government Act.
