Revised Council Expenses Policy C-AD24 (Elected Official Expenses Policy C-AD24)

### Proposed Motion

That Elected Official Expenses Policy C-AD24 be received for information, as presented.

### Administration Recommendation

Administration supports that revised Council Expenses Policy C-AD24 now be renamed as Elected Official Expenses Policy C-AD24.

### Purpose

Administration reviews Council policies and identifies revisions to reduce redundancy and to align with other Council policies for efficiency and transparency.

### Summary

In April 2020, Council approved revised Elected Official Remuneration Policy C-AD22. Policy C-AD22 was revised to include matters in Council Expenses Policy C-AD24, now to be renamed as Elected Official Expenses Policy C-AD24. Administration's review of Policy C-AD24 provides guidelines for the reimbursement of expenses incurred by Elected Officials in the performance of their duties and to comply with the provisions of Elected Official Remuneration Policy C-AD22.
