#### Purpose

Administration reviews Council policies and identify policies to be rescinded as they are no longer effective.

#### Summary

Council Code of Conduct Bylaw 2018-05 addresses matters that were previously in Council Norms and Values Policy C-AD20, Council Orientation Policy C-AD18, and the Code of Conduct for Council and Public Committee Members Policy C-AD21. Administration identified that Policies C-AD20, C-AD18, and C-AD21 are no longer required as matters within the policies have been since addressed by the Council Code of Conduct Bylaw 2018-05, the Municipal Government Act and the Code of Conduct for Elected Officials Regulation, and

the Chief Administrative Officer Bylaw 2014-30.
