Purpose

In support of the overall process to harmonize Wabamun within Parkland County's regulatory framework, this bylaw establishes specific fees and charges within the Hamlet of Wabamun for the 2021 year and repeals the Wabamun Master Rate and Fee schedule.

Summary

In accordance with Order in Council 386/2020 effective January 1, 2021 the Village of Wabamun was dissolved and the former area of the village designated as a hamlet in Parkland County. Under the provisions of Order in Council 386/2020 bylaws and resolutions of the former area of the village continue to apply until the bylaws or resolutions are repealed, amended or replaced by the Council of Parkland County. Bylaw 2021-16 repeals the former Villages Master Rate and Fee Schedule and also continues certain Hamlet of Wabamun specific rates for the remainder of 2021.
